STATUTE CCLVIII

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Given under the Common Seal of National University of Ireland, Galway, this sixteenth day of December, One Thousand Nine Hundred and Ninety-eight.

SCHEDULE - STATUTE CCLVIII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There are hereby established in the University the following fulltime Associate Professorships:

Associate Professorship (Untitled) No. 1
Associate Professorship (Untitled) No. 2
Associate Professorship (Untitled) No. 3
Associate Professorship (Untitled) No. 4
Associate Professorship (Untitled) No. 5
Associate Professorship (Untitled) No. 6
Associate Professorship (Untitled) No. 7
Associate Professorship (Untitled) No. 8
Associate Professorship (Untitled) No. 9
Associate Professorship (Untitled) No. 10

2. The annual stipend attaching to each of the foregoing Associate Professorships (Untitled) shall be the same as that attaching from time to time to the fulltime Associate Professorships of the University.
3. Each of the said Associate Professorships (Untitled) shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of each of the said Associate Professorships (Untitled) shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The foregoing Associate Professorships (Untitled) shall be established in the Faculties and in the subjects as Údarás na hOllscoile shall decide from time to time.
6. The holder of each of the said Associate Professorships (Untitled) shall carry out the duties of the Associate Professorship under the direction of such Professor or such Head of Department as Údarás na hOllscoile shall deem appropriate.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the sixteenth day of December, One Thousand Nine Hundred and Ninety-eight, and may be cited as Statute CCLVIII, National University of Ireland, Galway, or Stat. CCLVIII, Nat. Univ. of I., Galway.
