STATUTE CCLXIX

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Given under the Common Seal of National University of Ireland, Galway, this twenty-seventh day of June, Two Thousand and One.

SCHEDULE - STATUTE CCLXIX

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. Notwithstanding anything contained in any previous Statute of the University, and in particular in Chapter XI of Statute XVII, in Chapter I of Statute CXI and in Chapter I of Statute CCIII, the holder of a Junior Lectureship and the holder of a post of Applied Language Teacher shall be deemed to be, as from the date of appointment to such Junior Lectureship or such post of Applied Language Teacher, as the case may be, a member of such Faculty or Faculties of the University as may be determined from time to time by Regulation.
2. Notwithstanding anything contained in any previous Statute of the University, and in particular in Chapter XI of Statute XVII, in Statute XXIII, in Chapter I of Statute CXI and in Chapter I of Statute CCIII, the holder of a fulltime temporary contract teaching post in the University shall be entitled to attend and participate in meetings of such Faculty or Faculties of the University as may be determined from time to time by Regulation, but shall not be entitled to vote thereat and shall not be eligible for election as Dean of the Faculty.

Notwithstanding the foregoing provision, the holder of a fulltime temporary contract teaching post in the University who shall have completed at least three years' service in such a post in the University shall also be entitled to vote at meetings of such Faculty or Faculties as aforesaid, but shall not be eligible for election as Dean of the Faculty.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the twenty-seventh day of June, Two Thousand and One, and may be cited as Statute CCLXIX, National University of Ireland, Galway, or Stat. CCLXIX, Nat. Univ. of I., Galway.
