### **National University of Ireland, Galway**

#### **STATUTE CCLXXXII**

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

#### **Schedule - STATUTE CCLXXXII**

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.



## **CHAPTER I**

### **NEW ASSOCIATE PROFESSORSHIP**

1. There is hereby established in the University the following fulltime Associate Professorship:

#### **Associate Professorship of Biomedical Engineering.**

2. The annual stipend attaching to the foregoing Associate Professorship shall be the same as that attaching from time to time to the fulltime Associate Professorships of the University.
3. The said Associate Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of the said Associate Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of the said Associate Professorship shall carry out the duties of the Associate Professorship under the direction of the Head of the Department of Mechanical and Biomedical Engineering.

## **CHAPTER II**

1. There are hereby established in the University the following fulltime Senior Lectureships:

**Senior Lectureship (Untitled) No. 32**  
**Senior Lectureship (Untitled) No. 33**  
**Senior Lectureship (Untitled) No. 34**  
**Senior Lectureship (Untitled) No. 35**  
**Senior Lectureship (Untitled) No. 36**  
**Senior Lectureship (Untitled) No. 37**  
**Senior Lectureship (Untitled) No. 38**  
**Senior Lectureship (Untitled) No. 39**  
**Senior Lectureship (Untitled) No. 40.**

2. The annual stipend attaching to each of the foregoing Senior Lectureships (Untitled) shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.



3. Each of the said Senior Lectureships (Untitled) shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of each of the said Senior Lectureships (Untitled) shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The foregoing Senior Lectureships (Untitled) shall be established in the Faculties and in the subjects as Údarás na hOllscoile shall decide from time to time.

The holder of each of the said Senior Lectureships (Untitled) shall carry out the duties of the Senior Lectureship under the direction of such Professor or such Head of Department as Údarás na hOllscoile shall deem appropriate.

### CHAPTER III

#### DIRECTOR OF THE CENTRE FOR IRISH STUDIES

1. There is hereby established in the University the following fulltime post:

##### **Director of the Centre for Irish Studies.**

2. The annual stipend attaching to the foregoing post shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
3. The said post shall be a pensionable post in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of the said post shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of the said post shall carry out the duties of the post under the direction of the Board of Irish Studies or of an authorised senior member of the University.



## CHAPTER IV

### PROFESSORSHIP OF HEALTH PROMOTION

1. The Professorship of Health Promotion shall henceforth be known as the Professorship of Health Promotion and Public Health.

## CHAPTER V

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.

This Statute shall come into operation on the sixteenth day of January, Two Thousand and Four, and may be cited as Statute CCLXXXII, National University of Ireland, Galway, or Stat. CCLXXXII, Nat. Univ. of I., Galway.
