**STATUTE CCXLIX**

○ We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

**SCHEDULE - STATUTE CCXLIX**

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## CHAPTER I

### The Registrar of the University

1. Statute CCX, as amended by Statute CCXLVIII, is hereby further amended as follows:
  - a) by the substitution of the words "Such Election Meeting shall be held on a date appointed by the President, which date shall not be more than two months nor less than one fortnight before the date at which the Údarás na hOllscoile then in being shall go out of office" for the words, "Such Election Meeting shall take place at the same time as that appointed for the election by the Academic Council of the three other representatives of the Academic Council on the Governing Body" in Chapter I, Section 2, Subsection (c) thereof.
  - b) by the deletion of the words "(to be held by the Academic Council in accordance with Section 10, Chapter VI of Statute XVII)" in Chapter I, Section 2, Subsection (d) thereof.
  - c) by the deletion of the words "and shall be a representative of the Academic Council on the Governing Body" in Chapter I, Section 2, Subsection (d) thereof.

## CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the twenty-seventh day of February, One Thousand Nine Hundred and Ninety-eight, and may be cited as Statute CCXLIX, National University of Ireland, Galway, or Stat. CCXLIX, N.U.I., Galway.
