**STATUTE CCXLVII**

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty- third day of April, One Thousand Nine Hundred and Ninety-seven.

**SCHEDULE - DRAFT-STATUTE CCXLVII**

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.



## CHAPTER I

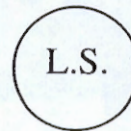
1. The Lectureship in Botany shall henceforth be known as the Lectureship (Untitled) No. 1.
2. The Lectureship (No. 5) in Physiology shall henceforth be known as the Lectureship (Untitled) No. 2.
3. The Lectureship in Zoology shall henceforth be known as the Lectureship (Untitled) No. 3.
4. The Lectureship in Engineering Computation shall henceforth be known as the Lectureship (Untitled) No. 4.
5. The Lectureship (No. 4) in English shall henceforth be known as the Lectureship (Untitled) No. 5.
6. The Lectureship (No. 2) in Experimental Medicine (with reference to animal behaviour) shall henceforth be known as the Lectureship (Untitled) No. 6.
7. The Lectureship (No. 4) in Experimental Physics shall henceforth be known as the Lectureship (Untitled) No. 7.
8. The Lectureship (No. 3) in French shall henceforth be known as the Lectureship (Untitled) No. 8.
9. The Lectureship (No. 3) in Mathematical Physics shall henceforth be known as the Lectureship (Untitled) No. 9.
10. The Lectureship (No. 1) in Economics shall henceforth be known as the Lectureship (Untitled) No. 10.
11. The foregoing Lectureships (Untitled) shall be established in the Faculties and in the subjects as the Governing Body shall decide from time to time.
12. The holder of each of the said Lectureships (Untitled) shall carry out the duties of the Lectureship under the direction of such Professor or such Head of Department as the Governing Body shall deem appropriate.



## CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-third day of April, One Thousand Nine Hundred and Ninety-seven, and may be cited as Statute CCXLVII, University College, Galway, or Stat. CCXLVII, Univ. Coll., Galway.
