

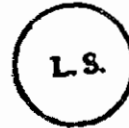

STATUTE CII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE CII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ASSOCIATE SECRETARY (ACCOUNTS)

1. There is hereby established in the College the post of Associate Secretary (Accounts).
2. The stipend attaching to the post shall be the same as that attaching from time to time to the Associate Professorships of the College.
3. The holder of the post of Associate Secretary (Accounts) shall carry out his duties under the direction of the Secretary-Bursar.
4. The holder of the post of Associate Secretary (Accounts) shall be subject to good conduct and the due fulfilment of his duties, and shall continue in office until he shall have attained the age of sixty-five years.

After attaining the said age, the Associate Secretary (Accounts) may be continued in office by the Governing Body from year to year for a period not exceeding five years provided that such

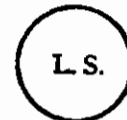
further continuance in office is recommended to the Governing Body by the President and is sanctioned by the Governing Body annually.

5. (a) The Post shall be a pensionable office within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holder of the post shall be entitled to payment of both pension and gratuity in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway, and the Statutes of the College.
 - (b) The annual stipend for the purpose of calculating pension and gratuity in accordance with the relevant provisions of the Statutes of the College, shall be deemed to be those payable at dates of retirement or death of the holder pursuant to the provisions of Section 2 of this Chapter.
 - (c) There shall be paid into the Pension Fund such additional sums as an Actuary shall certify to be necessary for providing such pension and gratuity as aforesaid.
6. The holder of the foregoing post shall be entitled to the annual allowance in respect of wife and children pursuant to Statute XXXVII and Statute LV of University College, Galway, as amended by any subsequent Statute of the said College.

CHAPTER II

1. Nothing herein contained shall affect any appointment made right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-eighth day of May, One Thousand Nine Hundred and Seventy-five and may be cited as Statute CII of University College, Galway, or Stat. CII Univ. Coll., Galway.
