STATUTE CIX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Scal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE-STATUTE CIX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. The posts of PROFESSORSHIP OF HISTORY (WITH SPECIAL REFERENCE TO IRISH HISTORY) and PROFESSORSHIP OF MODERN IRISH HISTORY are hereby extinguished and in lieu thereof there shall be established in the College in the event of their institution by the Senate of the National University of Ireland the following two full-time posts:

PROFESSORSHIP OF HISTORY PROFESSORSHIP (No. 2) OF HISTORY

CHAPTER II

1. The annual stipend of the holder of each of the foregoing full-time Professorships shall be the same as that attaching from time to time to the full-time Professorships of the College. The Governing Body may in its discretion in accordance with Chapter II of Statute LIV of University College, Galway, if the President (having regard to the qualifications and College service if any of the persons appointed) so recommends, fix the commencing stipend of each of the Professorships at any point in the incremental salary scale applicable thereto.

- 2. The holder of each of the foregoing Professorships shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- 3. (a) The two foregoing Professorships shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holders of the said Professorships shall be entitled to payment of both Pension and Gratuity under and in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway, and the Statutes of the College.
 - (b) The annual stipends for the purpose of calculating Pensions and Gratuities in accordance with the relevant provisions of existing Statutes of the College shall be those payable at dates of retirement or death of the holders pursuant to the provisions of the relevant Sections of this Chapter.
 - (c) There shall be paid into the Pension Fund such additional sums as an Actuary shall certify to be necessary for providing such Pensions and Gratuities as aforesaid.
- 4. The holders of the foregoing Professorships shall be entitled to the annual allowances in respect of wives and children pursuant to Statute XXXVII and Statute LV of University College, .Galway, as amended by any subsequent Statute of the said College.

CHAPTER III

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the twenty-sixth day of March, One Thousand Nine Hundred and Seventy-six and may be cited as Statute CIX, University College, Galway, or Stat. CIX Univ. Coll., Galway.
