STATUTE CLIV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-sixth day of June, One Thousand Nine Hundred and Eighty-one.

SCHEDULE - STATUTE CLIV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

NEW LECTURESHIP

1. There shall be established in the College in the event of its institution by the Senate of the National University of Ireland the following fulltime Lectureship:

LECTURESHIP (No. 5) IN BOTANY

CHAPTER II

- 1. The holder of the foregoing Lectureship shall carry out the duties of the Lectureship under the direction of the Professor of Botany.
- 2. The annual stipend attaching to the foregoing Lectureship shall be the same as that attaching from time to time to the fulltime Lectureships of the College.
- 3. The holder of the foregoing Lectureship shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years after which he shall be eligible for reappointment. If

reappointed he shall, subject to good conduct and the due fulfilment of his duties, hold office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and is sanctioned annually by the said Senate.

- 4. a) The foregoing Lectureship shall be a pensionable office within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holder of the Lectureship shall be entitled to payment of both Pension and Gratuity under and in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI and the other Statutes of University College, Galway.
 - b) The annual stipend for the purpose of calculating Pension and Gratuity in accordance with the relevant provisions of existing Statutes of the College shall be that payable at date of retirement or death of the holdepursuant to the provisions of Section 2 of this Chapter.
 - c) There shall be paid annually into the Pension Fund an additional sum equivalent to 15% of the stipend attaching to the Lectureship for the purpose of providing such Pension and Gratuity as aforesaid.

CHAPTER III

LECTURESHIP IN MICROBIOLOGY - DUTIES

 The holder of the Lectureship in Microbiology (Statute LVI) shall carry out the duties of the Lectureship under the direction of the Professor of Microbiology.

CHAPTER IV

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- This Statute shall come into operation on the twenty-sixth day of June, One Thousand Nine Hundred and Eighty-one and may be cited as Statute CLIV of University College, Galway, or Stat. CLIV, Univ. Coll., Galway.
