STATUTE CLIX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-sixth day of February, One Thousand Nine Hundred and Eighty-two.

SCHEDULE - STATUTE CLIX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I NEW LECTURESHIPS

1. There shall be established in the College, in the event of their institution by the Senate of the National University of Ireland, the following fulltime Lectureships:

Lectureship (No. 9) in Chemistry Lectureship (No. 10) in Chemistry

Lectureship (No. 5) in Ancient Classics

- 2. The annual stipend attaching to the foregoing Lectureships shall be the same as that attaching from time to time to the fulltime Lectureships of the College.
- 3. The holder of Lectureship (No. 9) in Chemistry shall carry out the duties of the Lectureship under the direction of the Professor of Chemistry. Notwithstanding that provision, the Governing Body shall have the right to assign, on the recommendation of the President, the direction of the said Lectureship to such Professor of Chemistry as it deems appropriate.
- 4. The holder of Lectureship (No. 10) in Chemistry shall carry out the duties of the Lectureship under the direction of the Professor of Inorganic Chemistry (within the Department of Chemistry). On the occurrence of a vacancy in the said Professorship and at any time thereafter, the Governing Body shall have the right to assign, on the recommendation of the President, the direction of the said Lectureship to such Professor of Chemistry as it from time to time deems appropriate.

- 5. The holder of Lectureship (No. 5) in Ancient Classics shall carry out the duties of the Lectureship under the direction of the Professor of Ancient Classics.
- 6. The holder of each of the said Lectureships shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years, after which he shall be eligible for reappointment. If reappointed he shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and is sanctioned annually by the said Senate.
- 7. (a) The foregoing Lectureships shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holder of each Lectureship shall be entitled to payment of both pension and gratuity under and in accordance with the provisions of Chapter III and Chapter III of Statute XXXVI and the other Statutes of University College, Galway.
 - (b) The annual stipend for the purpose of calculating pension and gratuity in accordance with the relevant provisions of existing Statutes of the College shall be that payable at the date of retirement or death of the holder pursuant to the provisions of Section 2 of this Chapter.
 - (c) There shall be paid annually into the Pension Fund an additional sum equivalent to 15% of the stipend attaching to each of the Lectureships for the purpose of providing such pension and gratuity as aforesaid.

CHAPTER II

LECTURESHIP (NO. 3) IN CHEMISTRY — DUTIES

1. The holder of Lectureship (No. 3) in Chemistry shall carry out the duties of the Lectureship under the direction of the Professor of Chemistry. Notwithstanding that provision, the Governing Body shall have the right to assign, on the recommendation of the President, the direction of the said Lectureship to such Professor of Chemistry as it deems appropriate.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.

2. This Statute shall come into operation on the twenty-sixth day of February, One Thousand Nine Hundred and Eighty-two and may be cited as Statute CLIX, University College, Galway, or Stat. CLIX, Univ. Coll., Galway.
