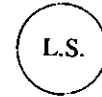

STATUTE CLVIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twentieth day of January, One Thousand Nine Hundred and Eighty-two.

SCHEDULE STATUTE CLVIII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. Notwithstanding anything contained in any previous Statute of the College, the stipends attached to the Offices of the Secretary-Bursar, Academic Secretary, Librarian, fulltime Professorships, fulltime Associate Professorships, Associate Secretaryships, fulltime Lectureships, part-time Professorships, part-time Associate Professorships and part-time Lectureships shall as from the 26th day of June, 1979 and as from the 26th day of June, 1980 be increased as set out in Table A to this Chapter to take account of the increases granted in the Civil Service on the recommendation of the Review Body on Higher Remuneration in the Public Sector in its Report No. 20 dated 30th October 1979 (PRL. 8148).
2. Notwithstanding anything contained in any previous Statute of the College, a contribution at the rate of 1½% of salary shall be payable annually in respect of the Widows' and Orphans' Pension Scheme by holders of the foregoing Offices appointed with effect from the 1st day of January, 1981 or thereafter.

## CHAPTER II

### AGREEMENT ON PAY POLICY 1980

1. Notwithstanding anything contained in any previous Statute of the College, the stipends attached to the Offices of the President, Secretary-Bursar, Academic Secretary, Librarian, fulltime Professorships, fulltime Associate Professorships, Associate Secretaryships and fulltime Lectureships shall as from the 1st day of October, 1980 be increased by 8% together with an amount of £52 per annum. The allowances attached to these offices shall be increased by 8% as from the same date. This increase shall be known as the Agreement on Pay Policy 1980 First Phase increase and shall apply for a period of eight months until the 31st day of May, 1981.
2. As from the 1st day of June, 1981 the stipends and allowances attached to the Offices mentioned in Section 1 of this Chapter shall be increased by 7%. This increase shall be known as the Agreement on Pay Policy 1980 Second Phase increase and shall apply for a period of six months until the 30th day of November, 1981.
3. The Governing Body shall have power to round to the nearest pound the amounts of all stipends and allowances in which an increase is provided in this Chapter.

## CHAPTER III

### AGREEMENT ON PAY POLICY, 1980 - PART-TIME POSTS

1. Notwithstanding anything contained in any previous Statute of the College, the annual stipend attached to each part-time Professorship, each part-time Associate Professorship and each part-time Lectureship shall as from the 1st day of October, 1980 and the 1st day of June, 1981, respectively, be increased as set out in respect to each post in Table A to this Chapter. These increases shall be known as the Agreement on Pay Policy 1980 First Phase and Second Phase increases, respectively, and shall apply for a period of eight months until the 31st day of May, 1981 and for a period of six months until the 30th day of November, 1981, respectively.

CHAPTER IV

PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement or at date of death shall be £25,700 from the 1st day of October 1980 and £27,499 from the 1st day of June 1981.

2. Notwithstanding anything contained in any previous Statute of the College, the annual stipend for the purpose of calculating in accordance with the relevant provisions of existing Statutes of the College the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent shall be that payable at date of retirement or death of the holder, subject to the provisions of Chapter I of Statute CXIII.

#### CHAPTER V

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twentieth day of January, One Thousand Nine Hundred and Eighty-two and may be cited as Statute CLVIII, University College, Galway, or Stat. CLVIII, Univ. Coll., Galway.
