STATUTE CLXV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE - STATUTE CLXV

All previous Statutes of University College, Galway, and particularly Statute CLXI, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

- 1. The Contributory Widows' and Children's Pension Plan established by Chapter III of Statute CLXI shall henceforth be known as the Contributory Spouses' and Children's Pension Plan.
- 2. Statute CLXI, Chapter III, Section 2 is hereby amended by the addition thereto of the following words:

"The Plan shall also apply to female participants as on December 31, 1982 who agree in writing on or before a date to be determined by the Governing Body to become members of the Plan and to those who become female participants after December 31, 1982."

3. In Statute CLXI, Chapters I, II, III, IV and V and Appendix I, words importing the masculine gender shall be deemed to include the feminine and words importing the feminine gender shall be deemed to include the masculine.

4. Statute CLXI, Chapter III, Section 10, Subsection (a), Paragraph (ii) is hereby amended by the substitution of the word 'commutation' for the word 'computation' therein.

CHAPTER II

- I. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the first day of December, One Thousand Nine Hundred and Eighty-two, and may be cited as Statute CLXV, University College, Galway, or Stat. CLXV, Univ. Coll., Galway.
