#### STATUTE CLXXXVII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

### . SCHEDULE — STATUTE CLXXXVII

All previous Statutes of University College, Galway, and, in particular, Statutes CLXI and CLXV shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## **CHAPTER I**

1. Statute CLXI, Chapter III, Section 10, Subsection (a), Paragraph (ii) is hereby amended by the addition thereto of the following words after the words "for a period in excess of forty years":

"and also provided that a deduction under this Paragraph shall not be made in the case of holders of the posts listed in Subsections (a) and (b) of Section 7 of Chapter II of this Statute who had pensionable service in the Pension Fund established by Chapter XXV of Statute XVII of University

College, Galway, or in Pension Fund No. 2 established by Chapter I of Statute LXI of University College, Galway, for the period from the date of their appointment under the said Statutes to the date December 31, 1982".

- 2. Statute CLXI, Appendix I, Part I, Paragraph I is hereby amended by renumbering Subparagraph (b) as Subparagraph (c) and Subparagraph (c) as Subparagraph (d), by the substitution of the words "in Subparagraph (c)" for the words "in Subparagraph (b)" therein, and by the addition thereto of the following Subparagraph:
  - "(b) The Scheme shall also apply to the holder of any post included in the Pension Fund established by Chapter XXV of Statute XVII or in Pension Fund No. 2 established by Chapter I of Statute LXI who shall resign from such post on or after April 30, 1982 in order to take up any post cited in Subsection (a) of Section 7 of Chapter II of Statute CLXI, provided that the holder of a Lectureship on appointment to an Associate Professorship shall retain the option to remain in the Pension Fund established by Statute XVII."
- 3. Statute CLXI, Appendix I, Part I, Paragraph 1, Subparagraph (c), as amended by Section 2 of Chapter I of this Statute, is hereby further amended by the substitution of the words "March 31, 1987" for the words "December 31, 1982" therein.
- 4. Statute CLXI, Appendix I, Part I, Paragraph 1, Subparagraph (d), as amended by Section 2 of Chapter I of this Statute, is hereby further amended by the insertion of the words "and subparagraph (b)" after the words "in subparagraph (a)" and by the substitution of the words "in subparagraph (c)" for the words "in subparagraph (b)" therein.

#### CHAPTER II

 Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College. 2. This Statute shall come into operation on the twenty-seventh day of June, One Thousand Nine Hundred and Eighty-six, and may be cited as Statute CLXXXVII, University College, Galway, or Stat. CLXXXVII, Univ. Coll., Galway.
