STATUTE CLXX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seaf of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this eighteenth day of May, One Thousand Nine Hundred and Eighty four.

Schedule - Statute CLXX

All previous Statutes of University College, Galway, shall be read and construed with the alteration, additions and modifications hereinafter set forth.

Chapter I

1. There shall be established in the College, in the event of their institution by the Senate of the National University of Ireland, the following fulltime Lectureships:

Lectureship (No. 6) in Botany Lectureship (No. 2) in Political Science and Sociology

- 2. The annual stipend attaching to the foregoing Lectureships shall be the same as that attaching from time to time to the fulltime Lectureships of the College.
- 3. The holder of Lectureship (No. 6) in Botany shall carry out his duties under the direction of the Professor of Botany.
- 4. The holder of Lectureship (No. 2) in Political Science and Sociology shall carry out his duties under the direction of the Professor of Political Science and Sociology.

- 5. The holder of each of the said Lectureships shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years, after which he shall be eligible for reappointment. If reappointed, he shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- 6. The foregoing Lectureships shall be pensionable offices in accordance with the provisions of Statute CLXI and Statute CLXV, University College, Galway.

Chapter II

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the eighteenth day of May, One Thousand Nine Hundred and Eighty-four and may be cited as Statute CLXX, University College, Galway, or Stat. CLXX, Univ. Coll., Galway.
