STATUTE CVI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE-STATUTE CVI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

ASSOCIATE PROFESSORSHIP OF CHEMISTRY (WITH SPECIAL REFERENCE TO PHYSICAL ORGANIC CHEMISTRY)

- 1. There shall be established in the College in the event of its institution by the Senate of the National University of Ireland a full-time Associate Professorship of Chemistry (with special reference to Physical Organic Chemistry).
- 2. The annual stipend attached to the Associate Professorship of Chemistry (with special reference to Physical Organic Chemistry) shall be the same as that attaching from time to time to the full-time Associate Professorships of the College. The said annual stipend shall, however, be non-incremental.
- 3. The holder of the Associate Professorship of Chemistry (with special reference to Physical Organic Chemistry) shall carry out his duties under the direction of the Professor of Chemistry.

- 4. The holder of the foregoing Associate Professorship shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years and thereafter be continued in office for five further years: PROVIDED THAT such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President of the said College and is sanctioned annually by the said Senate.
- 5. (a) The foregoing Associate Professorship shall be a pensionable office within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holder of the said Associate Professorship shall be entitled to payment of both Pension and Gratuity in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway, and the Statutes of the College.

(b) The annual stipend for the purpose of calculating Pension and Gratuity in accordance with the relevant provisions of the Statutes of the College shall be deemed to be that payable at date of retirement or death of the holder pursuant to the provisions of Section 2 of this Chapter.

(c) There shall be paid into the Pension Fund such additional sum as an Actuary shall certify to be necessary for providing such Pension and Gratuity as aforesaid.

6. The holder of the foregoing Associate Professorship shall be entitled to annual allowances in respect of wife and children pursuant to Statute XXXVII and Statute LV of University College, Galway, as amended by any subsequent Statute of the said College.

CHAPTER II

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- This Statute shall come into operation on the twenty-first day
 of January, One Thousand Nine Hundred and Seventy-six and
 may be cited as Statute CVI of University College, Galway, or
 Stat. CVI Univ. Coll., Galway.
