STATUTE CXIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE-STATUTE CXIII

All previous Statutes of University College, Galway, and particularly Statute LI (specifically Chapter I, Section 4 (a)) and Statute XCVIII (specifically Chapters I and II), shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

AMENDMENT OF THE PROVISIONS GOVERNING THE CALCULATION OF INCREASE OF PENSION OF ALL FUTURE STATUTORY AND NON-STATUTORY STAFF

- 1. The provisions of this Statute shall apply to any person appointed to any Statutory pensionable post, Professorship, Lectureship or Office or to any post as listed in Table A referred to in Statute LXI, after the date of coming into operation of this Statute.
- 2. The provisions of this Statute shall also apply to any person who already holds any Statutory pensionable post, Professorship, Lectureship or Office or any post as listed in Table A referred to in Statute LXI, at the date of coming into operation of this Statute and who thereafter resigns from such a post and is appointed to any other post in the College.

3. The proviso in Section 4 (a) of Chapter I of Statute LI whereby; the holder of a Professorship, Lectureship or Office (or Professorship and Office combined) shall be entitled to have his pension calculated and paid (as from the date of increase of his retiring salary) as if his retiring salary had at the date of his retirement been the same amount as the retiring salary payable after such increase; is hereby rescinded and in lieu thereof is substituted the following proviso: WHENEVER and so often as the retiring salary attached to a pensionable Professorship, Lectureship or Office (or Professorship and Office combined) shall be hereafter increased any former holder of the same or the comparable Professorship, Lectureship or Office (or Professorship and Office combined) shall be entitled to have his pension calculated and paid (as from the first day of July each year) as if his retiring salary had at the date of his retirement been the same amount as the retiring salary payable after such increase.

CHAPTER II

AMENDMENT OF THE PROVISIONS GOVERNING THE CALCULATION OF INCREASE OF PENSION OF ALL FUTURE WIDOWS OF STATUTORY AND NON-STATUTORY STAFF

- 1. The sentence contained in Paragraph 1 of Chapter II of Statute XCVIII: The "current salary" referred to in this Statute shall mean the salary for the time being applicable at the same point on the salary scale as the participant had at the date of his death or retirement; is hereby amended to read as follows: The "current salary" referred to in this Statute shall mean the salary on the first day of July each year applicable at the same point on the salary scale as the participant had at the date of his death or retirement.
- The provisions or this Statute shall apply to the Widow of any
 person appointed to any Statutory pensionable post, Professorship, Lectureship or Office or to any post as listed in Table A
 referred to in Statute LXI after the date of coming into operation
 of this Statute.
- 3. The provisions of this Statute shall also apply to the Widow of any person who already holds any Statutory pensionable post, Professorship, Lectureship or Office or any post as listed in Table A referred to in Statute LXI, at the date of coming into operation of this Statute and who thereafter resigns from such a post and is appointed to any other post in the College.

CHAPTER III

 Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College. 2. This Statute shall come into operation on the Nineteenth day of January, One Thousand Nine Hundred and Seventy-seven and may be cited as Statute CXIII, University College, Galway, or Stat. CXIII, Univ. Coll., Galway.
