STATUTE CXLII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE CXLII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

NEW PROFESSORSHIPS AND LECTURESHIPS

1. There shall be established in the College in the event of their institution by the Senate of the National University of Ireland, the following full-time posts:

Professorship of Mechanical Engineering Professorship of Electronic Engineering

Lectureship (No. 1) in Electronic Engineering

Lectureship (No. 2) in Electronic Engineering Lectureship (No. 3) in Electronic Engineering

Lectureship (No. 1) in Mechanical Engineering Lectureship (No. 2) in Mechanical Engineering

Lectureship (No. 3) in Mechanical Engineering

Lectureship in Engineering Computation

Lectureship (No. 2) in Industrial Engineering Lectureship (No. 3) in Industrial Engineering

Lectureship in Production Engineering

Lectureship in Materials Engineering

Lectureship (No. 1) in Applied Physics and Electronics Lectureship (No. 2) in Applied Physics and Electronics

Lectureship in Management Information Systems

CHAPTER II

- 1. The holders of the following Lectureships shall carry out the duties of the Lectureships as follows:
 - (a) Lectureships (No. 1, No. 2 and No. 3) in Electronic Engineering—under the direction of the Professor of Electronic Engineering.
 - (b) Lectureships (No. 1, No. 2 and No. 3) in Mechanical Engineering—under the direction of the Professor of Mechanical Engineering.
 - (c) Lectureship in Engineering Computation under the direction of the Professor of Civil Engineering.
 - (d) Lectureships (No. 2 and No. 3) in Industrial Engineering—nnder the direction of the Professor of Industrial Engineering.
 - (e) Lectureship in Production Engineering under the direction of the Professor of Industrial Engineering.
 - (f) Lectureship in Materials Engineering—under the direction of the Professor of Industrial Engineering.
 - (g) Lectureships (No. 1 and 2) in Applied Physics and Electronics —under the direction of the Head of the Department of Experimental Physics.
 - (h) Lectureship in Management Information Systems—under the direction of the Professor of Accountancy and Finance.
- 2. In the event of a vacancy, for any reason, in any of the Professorships mentioned in Section 1 of this Chapter, the holder of each Lectureship named therein as carrying out his duties under the direction of that Professor shall, for the duration of the vacancy, carry out his duties under the direction of such Professor as the Governing Body may from time to time decide.
- 3. The stipend attaching to each of the foregoing Professorships shall be the same as that attaching from time to time to the full-time Professorships of the College.
- 4. The stipend attaching to each of the foregoing Lectureships shall be the same as that attaching from time to time to the full-time Lectureships of the College.
- 5. The Holder of each of the foregoing Professorships shall, subject to good conduct and due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years PROVIDED that such further continuence in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.

- 6. The Holder of each of the foregoing Lectureships shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years after which he shall be eligible for re-appointment. If re-appointed he shall, subject to good conduct and the due fulfilment of his duties, hold office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- 7. (a) The foregoing Professorships and Lectureships shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The Holder of each of the foregoing Professorships and the Holder of each of the foregoing Lectureships shall be entitled to payment of both Pension and Gratuity under, and in accordance with, the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway and the Statutes of the College.
 - (b) The annual stipend for the purpose of calculating pension and gratuity in accordance with the relevant provisions of existing statutes of the College shall be that payable at the date of retirement or death of the Holder pursuant to the provisions of the relevant section of this Chapter.
 - (c) There shall be paid annually into the Pension Fund an additional sum equivalent to 15% of the stipend to each of the foregoing Professorships and Lectureships for the purpose of providing such Pension and Gratuity as aforesaid.

CHAPTER III

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- This Statute shall come into operation on the twenty-fourth day of October, One Thousand Nine Hundred and Seventy-nine and may be cited as Statute CXLII University College, Galway, or Stat. CXLII, Univ. Coll., Galway.
