STATUTE CXV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-third day of February, 1977.

SCHEDULE—STATUTE CXV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER 1

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS AS FROM THE FIRST DAY OF AUGUST, 1976.

1. Notwithstanding anything contained in any previous Statute of the College, the stipends and marriage allowances attached to the offices of President, Secretary-Bursar, Academic Secretary, Librarian, full-time Professorships, full-time Associate Professorships, Associate Secretaryships and full-time Lectureships shall, as and from the first day of August, 1976 be increased by three per cent, together with an annual amount of £104, subject to a maximum increase of £261 per annum. This increase shall be known as the Employer-Trade Union Interim National Agreement 1976 increase.
2. The Governing Body shall have power to round to the nearest pound the amounts of all stipends in which an increase is provided in this Chapter.

CHAPTER II

1. Notwithstanding anything contained in any previous Statute of the College, the annual stipend attached to each part-time Professorship and each part-time Lectureship shall as from the first day of August 1976 be increased to the sum set opposite the respective titles of the said Professorships and Lectureships as follows:

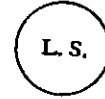

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-third day of February, One Thousand Nine Hundred and Seventy-seven and may be cited as Statute CXV of University College, Galway, or Stat. CXV Univ. Coll., Galway.
