# ACHT CHOLAISTE PHRIOMH-SCOILE NA GAILLIMHE, 1929. UNIVERSITY COLLEGE, GALWAY. STATUTE CXXV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts. DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

### SCHEDULE—STATUTE CXXV

All previous Statutes of University College, Galway, particularly Statute XLIV shall be read and construed with the alterations, additions and modifications hereinafter set forth.

#### CHAPTER I

1. The Part-time Lectureship in Bacteriology which was instituted by Statute XLIV, University College, Galway, is hereby extinguished.

### CHAPTER II

### NEW LECTURESHIPS-PART-TIME

 There shall be established in the College in the event if their institution by the Senate of the National University of Ireland the following part-time posts:

# LECTURESHIP (No. 3) IN MEDICINE (PART-TIME)

# LECTURESHIP IN MEDICAL MICROBIOLOGY (PART-TIME)

### CHAPTER III

- The Holders of the following Part-time Lectureships shall carry out the duties of the lectureships as follows:
  - (a) Lectureship (No. 3) in Medicine (Part-time)—under the direction of the Professor of Medicine.
  - (b) Lectureship in Medical Microbiology (Part-time) under the direction of the Professor of Bacteriology.

- 2. The Annual Stipend of each of the Holders of the foregoing Parttime Lectureships shall be as follows:
  - (a) Lectureship (No. 3) in Medicine (Part-time)—£2,267;
  - (b) Lectureship in Medical Microbiology (Part-time) £2,267.
- 3. The Holders of each of the foregoing Part-time Lectureships shall, subject to good conduct, and the due fulfilment of his duties hold office for seven years after which he shall be eligible for re-appointment. If re-appointed he shall, subject to good conduct and the due fulfilment of his duties, hold office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- 4. The Holders of each of the foregoing Part-time Lectureships shall be entitled to the annual allowances in respect of children pursuant to Statute XXVII and Statute LV, University College, Galway, as amended by any subsequent Statute of the said College.
- 5. The Holders of each of the foregoing Part-time Lectureships shall be required to give clinical instruction to the Undergraduate and Postgraduate students of the College at such hours and in such hospitals as the Academic Council may prescribe subject to review by the Governing Body.

### CHAPTER IV

# LECTURESHIP IN PREVENTIVE MEDICINE (PART-TIME)—DUTIES

1. The Holder of the Lectureship in Preventive Medicine (Parttime) shall carry out the duties of the Parttime Lectureship under the direction of the Professor of Social Medicine.

### CHAPTER V

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the Second day of December, One Thousand Nine Hundred and Seventy-seven, and may be cited as Statute CXXV, University College, Galway, or Stat. CXXV Univ. Coll., Galway.
