### UNIVERSITY COLLEGE, GALWAY

## STATUTE CXXXIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto, for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-seventh day of October, 1978.

#### SCHEDULE—STATUTE CXXXIII

All previous Statutes of University College, Galway and particularly Statute XVII (specifically Chapter XIV thereof) shall be read and construed with the alterations, additions and modifications hereinafter set forth.

#### CHAPTER I

#### AMENDMENT OF STATUTE XVII

- Statute XVII, Chapter XIV, Section I is hereby amended as follows:
  - (i) Subsection (a) shall be amended to read as follows:
    - "(a) Upon the occurrence of a vacancy in any such office, or when it shall become known that such vacancy shall occur within eighteen months, the President or his Deputy or the Acting President, as the case may be, shall call Meetings of the Academic Council and of the Governing Body respectively, the date fixed for the Meeting of the Academic Council being prior to that appointed for the Meeting of the Governing Body."
  - (ii) Subsection (b) shall be amended to read as follows:
    - "(b) The Academic Council at its Meeting or at an adjournment thereof shall make a Report to the Governing Body in reference to the Representations to be made to the Senate as to the filling of such vacancy or impending vacancy".

(iii) Subsection (d) shall be amended to read as follows:

"(d) If the Governing Body shall be of opinion that the office should not be extinguished, and that no variation should be made in the terms upon which such office has been held, notice of the vacancy or impending vacancy and of the intention to appoint thereto shall be given by the Governing Body by advertisement in such newspapers and at such time as it shall direct."

(iv) Subsection (e) shall be amended to read as follows:

"(e) If the Governing Body shall be of opinion that a variation in the terms upon which such office has been held should be made, and shall have made the Statute necessary for that purpose, such Statute not to come into operation until the office concerned shall have become vacant, and have laid the same before both Houses of the Oireachtas and have caused notice of such Statute to be published in the Iris Oifigiúil, notice of the vacancy or impending vacancy and of the intention to appoint thereto, subject to the provisions of such Statute, shall be given by the Governing Body by advertisement in such newspapers and at such time as it shall direct."

(v) Subsection (g) shall be amended to read as follows:

"(g) Upon the receipt of the applications of Candidates for the vacancy or impending vacancy from the Secretary, the President or his Deputy, or the Acting-President, as the case may be, shall call a Meeting of the Governing Body and shall communicate with the Academic Council, and obtain from it a Report in reference to all Candidates who have sent in applications, and shall submit the same to the Meeting of the Governing Body."

(vi) The following new subsection shall be added after Subsection (m):

"(n) In the case of an impending vacancy, the appointment of a candidate by the Senate shall not take effect until the vacancy shall have occurred."

#### CHAPTER II

 Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.

 This Statute shall come into operation on the twenty-seventh day of October, One Thousand Nine Hundred and Seventyeight, and may be cited as Statute CXXXIII, University College, Galway, or Stat. CXXXIII Univ. Coll., Galway.
