STATUTE CXIV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE CXIV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

NEW PROFESSORSHIP AND LECTURESHIP

1. There shall be established in the College in the event of their institution by the Senate of the National University of Ireland, the following full-time posts:

PROFESSORSHIP OF LAW
LECTURESHIP (No. 1) IN LAW

CHAPTER II

1. The holder of the post of Lectureship (No. 1) in Law shall carry out the duties of the Lectureship under the direction of the Professor of Law.
2. The stipend attaching to the post of Professorship of Law shall be the same as that attaching from time to time to the full-time Professorships of the College.
3. The stipend attaching to the post of Lectureship (No. 1) in Law shall be the same as that attaching from time to time to the full-time Lectureships of the College.

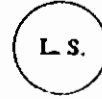
4. The Holder of the foregoing Professorship shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
5. The Holder of the foregoing Lectureship shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years after which he shall be eligible for re-appointment. If re-appointed he shall, subject to good conduct and the due fulfilment of his duties, hold office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years. PROVIDED that such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
6. (a) The foregoing Professorship and Lectureship shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The Holder of the Professorship and the Holder of the Lectureship shall be entitled to payment of both Pension and Gratuity under, and in accordance with, the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway and the Statutes of the College.
 - (b) The annual stipend for the purpose of calculating pension and gratuity in accordance with the relevant provisions of existing statutes of the College shall be that payable at the date of retirement or death of the Holder pursuant to the provisions of the relevant section of this Chapter.
 - (c) There shall be paid into the Pension Fund such additional sum as an actuary shall certify to be necessary for providing such Pension and Gratuity as aforesaid.
7. The Holders of the foregoing Professorship and Lectureship shall be entitled to the annual allowance in respect of a wife and children pursuant to Statute XXXVII and Statute LV of University College, Galway, as amended by any subsequent Statute of the said College.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.

2. This Statute shall come into operation on the twenty-third day of February, One Thousand Nine Hundred and Seventy-seven and may be cited as Statute CXIV, University College, Galway or Stat. CXIV, Univ., Col., Galway.
