STATUTE LXXXII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE LXXXII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

Stipends and Allowances attached to Statutory Offices, Professorships and Lectureships from 1st April 1970 until 31st December 1970.

1. Notwithstanding anything contained in any previous Statute of the College, the stipends and allowances attached to the Offices, Professorships and Lectureships referred to in Table A and in Table B to this Chapter shall, on and from the first day of April 1970, be the stipends and allowances set forth in the said tables.
2. This Chapter shall be deemed to have come into operation on the 31st day of March 1970.

TABLE A:

1. The annual stipend of the President shall be £6,661. In addition, he shall be entitled to residence, fuel and light as heretofore valued for pension purposes at £1,081 per annum, and to a non-pensionable allowance of £1,081 in respect of the expenses of his office.
2. The annual stipend of the holder of each of the following full-time offices namely:
 - (a) The office of Secretary-Bursar,
 - (b) The office of Academic Secretary,
 - (c) The office of Librarian,
 shall be £3,620 on appointment, increasing to a maximum of £4,440 by annual increments of £102.50 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
3. The annual stipend of the holder of each full-time Professorship shall be £3,620 on appointment, increasing to a maximum of £4,440 by annual increments of £102.50 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
4. The annual stipend of the holder of each full-time Associate Professorship shall be £3,945. The said annual stipend shall be non-incremental.
5. The annual stipend of the holder of each full-time Lectureship shall be £2,428 on appointment increasing to a maximum of £3,398 by annual increments of £97 for each completed year of service since appointment subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.

CHAPTER II

Stipends and Allowances attached to Statutory Offices, Professorships and Lectureships as from 1st January 1971

1. Notwithstanding anything contained in Chapter I of this Statute or in any previous Statute of the College, the stipends and allowances attached to the Offices, Professorships and Lectureships referred to in Table A and Table B to this Chapter shall, on and from the first day of January 1971, be the stipends and allowances set forth in the said tables.
2. This Chapter shall be deemed to have come into operation on the 31st day of December 1970.

TABLE A:

1. The annual stipend of the President shall be £7,284. In addition, he shall be entitled to residence, fuel and light as heretofore valued for pension purposes at £1,188 per annum, and to a non-pensionable allowance of £1,188 in respect of the expenses of his office.
2. The annual stipend of the holder of each of the following full-time offices namely:
 - (a) The office of Secretary-Bursar,
 - (b) The Office of Academic Secretary,
 - (c) The office of Librarian,
 shall be £3,948 on appointment, increasing to a maximum of £4,860 by annual increments of £114 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.

3. The annual stipend of the holder of each full-time Professorship shall be £3,948 on appointment, increasing to a maximum of £4,860 by annual increments of £114 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
4. The annual stipend of the holder of each full-time Associate Professorship shall be £4,314. The said annual stipend shall be non-incremental.
3. The annual stipend of the holder of each full-time Lectureship shall be £2,652 on appointment increasing to a maximum of £3,732 by annual increments of £108 for each completed year of service since appointment, subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.

CHAPTER III

Marriage and Children's Allowances from 1st April 1970 until 31st December 1970

1. Section I of Chapter III of Statute LXXXI of University College, Galway is hereby amended: (a) by the substitution of the figure £91 for the figure £85 mentioned therein; (b) by the substitution of the figure £64 for the figure £60 mentioned therein; (c) by the substitution of the figure £32 for the figure £30 mentioned therein; (d) by the substitution of the figure £24 for the figure £22.50 mentioned therein.
2. This Chapter shall be deemed to have come into operation on the thirty-first day of March, 1970, and the increased allowances set out in Section I thereof shall be payable as and from the first day of April 1970 until 31st day of December 1970.
3. This Chapter shall be deemed to have lapsed with the coming into operation of Chapter IV of this Statute.

CHAPTER IV

Marriage and Children's Allowances as from 1st January 1971

1. Section I of Chapter III of Statute LXXXI of University College, Galway is hereby amended: (a) by the substitution of the figure £96 for the figure £85 mentioned therein; (b) by the substitution of the figure £72 for the figure £60 mentioned therein; (c) by the substitution of the figure £36 for the figure £30 mentioned therein; (d) by the substitution of the figure £27 for the figure £22.50 mentioned therein.
2. This Chapter shall be deemed to have come into operation on the thirty-first day of December 1970, and the increased allowances set out in Section I hereof shall be payable as and from the first day of January 1971.

CHAPTER V

Pensions and Gratuities

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement or at date of death shall be £7,742 as and from the first day of April 1970 until the 31st day of December, 1970 and £8,472 thereafter.

For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death, shall be deemed to be £2,160, or such greater amount as may be specified by resolution of the Governing Body.

2. Instead of the sum now being paid annually into the Statutory Pensionable Officers' Pension Fund, there shall henceforth be paid and transferred to the said fund out of the annual income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto an annual sum of £48,000.
3. On coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships or Pensionable Officers shall be entitled to have their current pension calculated and paid in the manner and subject to the conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII, Statute LXXX and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV.

CHAPTER VI

Part-time non-Pensionable Associate Professorship of Medicine

1. There shall be established in the College in the event of its institution by the Senate of the National University of Ireland a part-time non-Pensionable Associate Professorship of Medicine.
2. The annual stipend attached to the part-time non-Pensionable Associate Professorship of Medicine shall be £1,500. The said annual stipend shall be non-incremental.
3. The holder of the part-time Associate Professorship of Medicine shall carry out his duties under the direction of the Professor of Medicine.
4. The holder of the foregoing Associate Professorship shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED THAT such further continuance in office is recommended to the Senate of the National University of Ireland by the said Governing Body with the approval of the President of the said College and is sanctioned annually by the said Senate.
5. The holder of the part-time Associate Professorship of Medicine shall be required to give clinical instruction to the Undergraduate and Postgraduate students of the College at such hours and in such hospitals as the Academic Council may prescribe subject to review by the Governing Body.
6. The holder of the part-time Associate Professorship of Medicine shall be entitled to the annual allowances in respect of children payable in pursuance to Statute XXXVII and subsequent amendments.

CHAPTER VII

1. The Professorship of Physics (with special reference to Quantum and Theoretical Solid State Physics—in the Department of Experimental Physics) established by Chapter II of Statute LXXIX of University College Galway is hereby extinguished and in lieu thereof there shall be established in the College, in the event of its institution by the Senate of the National University of Ireland a Professorship of Applied Physics (in the Department of Experimental Physics).

CHAPTER VIII

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on Thirtieth day of November, One Thousand Nine Hundred and Seventy and may be cited as Statute LXXXII of University College, Galway, or Stat. LXXXII Univ. Coll., Galway.
