## STATUTE LXXXVI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

#### SCHEDULE-STATUTE LXXXVI

All previous Statutes of University College, Galway shall be read and construed with the alterations, additions and modifications hereinafter set forth.

### CHAPTER I

#### NEW PROFESSORSHIPS AND LECTURESHIPS

1. There shall be established in the College in the event of their institution by the Senate of the National University of Ireland the following posts:

Professorship of Pharmacology (within the Department of Experimental Medicine and Practical Pharmacology).

Professorship of Radiology (Part-time)

Lectureship (No. 7) in Chemistry

Lectureship (No. 2) in Radiology (Part-time)

Lectureship (No. 3) in Radiology (Part-time).

- 2. The Holder of the full-time Lectureship in Chemistry shall carry out his duties under the direction of the Professor of Chemistry. The Holders of the part-time Lectureships in Radiology shall carry out their duties under the direction of the Professor of Radiology.
- 3. The annual stipend of the Holder of the Professorship of Pharmacology shall be  $\pounds 4,052$  on appointment, increasing to a maximum of  $\pounds 4,964$  by annual increments of  $\pounds 114$  for each completed year of service since appointment.
  - "The Governing Body may in its discretion in accordance with Chapter II of Statute LIV of University College, Galway, if the President (having regard to the qualifications and College service, if any, of the person appointed) so recommends fix the commencing stipend of the Professorship at any point in the incremental salary scale applicable thereto.
- 4. The annual stipend of the holder of the Lectureship in Chemistry shall be £2,756 on appointment, increasing to a maximum of £3,836 by annual increments of £108 for each completed year of service since appointment.

The Governing Body may in its discretion in accordance with Chapter II of Statute LIV of University College, Galway, if the President (having regard to the qualifications and College service, if any, of the person appointed) so recommends fix the commencing stipend of the Lectureship at any point on the incremental scale applicable thereto.

- 5. The annual stipend of the Holder of the Professorship of Radiology shall be £2,482.
- 6. The annual stipend of each of the Holders of the foregoing part-time Lectureships in Radiology shall be £880.
- 7. The Holder of each of the foregoing Professorships shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Gody with the approval of the President and is sanctioned annually by the said Senate.
- 8. The Holder of each of the foregoing Lectureships in Radiology and the Lectureship in Chemistry shall subject to good conduct and to the due fulfilment of his duties hold office for seven years after which he shall be eligible for reappointment. If

reappointed he shall subject to good conduct and the due fulfilment of his duties hold office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and is sanctioned annually by the said Senate.

- 9. (a) The foregoing Professorship of Pharmacology, Professorship of Radiology and Lectureship in Chemistry shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and, shall be annexed to the appropriate Table of
  - the Pension Scheme. The Holders of the Professorships and the Lectureship shall be entitled to payment of both Pension and Gratuity in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway, and of the Statutes of the College.
  - (b) The annual stipend for the purpose of calculating Pension and Gratuity in accordance with the relevant provisions of the Statutes of the College shall be deemed to be that payable at date of retirement or death of the Holder pursuant to the provisions of the relevant sections of this Chapter, and subject to the provisions of Chapter I of Statute LXXII of University College, Galway.
  - (c) There shall be paid into the Pension Fund such additional sum as an actuary shall certify to be necessary for providing such Pension and Gratuity as aforesaid.
- 10. The Holders of the foregoing Professorships and Lectureships shall be entitled to annual allowances in respect of a wife and children pursuant to Statute XXXVII, Statute LV and Statute LXXXII of University College, Galway.

11. The Holder of the part-time Professorship of Radiology and the Holders of the part-time Lectureships in Radiology shall be required to give clinical instruction to the Undergraduate and Postgraduate students of the College at such hours and in such hospitals as the Academie Council may prescribe subject to review by the Governing Body.

#### CHAPTER II

1. The existing part-time Professorship of Therapeutics, Pharmacology, and Materia Medica shall be extinguished as soon as a vacancy occurs in that Professorship.

## CHAPTER III

- 1. Nothing herein contained shall affect any appointment made right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the day of One Thousand Nine Hundred and and may be cited as Statute LXXXVI University College, Galway, or Stat. LXXXVI Univ. Coll., Galway.
