SCHEDULE-STATUTE XCIX


All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

DEPARTMENT OF EXPERIMENTAL PHYSICS HEAD OF DEPARTMENT

- 1. There shall be a Department of Experimental Physics which shall comprise the Professorship of Experimental Physics, the Professorship of Electron Physics, the Professorship of Applied Physics, the Associate Professorship of Physics, the existing Lectureships in Experimental Physics, together with any such other Professorships and Lectureships as the Governing Body, after due consultation with the Head of the Department, the Departmental Committee, the relevant Faculty of Faculties, the Academic Council, and the holders for the time being (if any) of such other Professorships and Lectureships may decide in the future.
- 2. The Department shall be administered by the Head of the Department. In the administration of the Department he shall consult on a regular basis with the Departmental Committee, in particular in relation to matters arising for consideration under Sections (6), (8), and (9) of this Chapter.

The Head of the Department, excepting the first Head, shall be appointed in the manner prescribed by this Chapter from among the Professors, including the Associate Professors, of the Department The period of office of the Head of Department shall be three years. The Headship will not normally be renewable until the expiry of a further three years.

- 4. The first Head of Department shall be the Professor of Experimental Physics appointed in succession to the Professor of Experimental Physics who resigned the Professorship of Experimental Physics in 1973 Each subsequent Head shall be appointed according to a scheme agreed by the Departmental Committee, and, in the absence of agreement, by the President after consultation with the Departmental Committee and the Deans of the Faculties of the College.
- 5. The Departmental Committee shall comprise the Head of Department who shall be its Chairman, the other Professors (including Associate Professors) of the Department, the Lecturers of the Department who are full members of the Faculty of Science, and the permanent Junior Lecturers of the Department. The Committee may, however, co-opt, on an annual basis, other members of the academic or other staff of the Department to be members of the Departmental Committee. The Committee shall meet not less than twice per term.
- 6: All members of Academic staff and all members of the technical, administrative, secretarial, and ancillary staff appointed for duty in the Department shall carry out their duties under the directions of the Head of the Department.
- 7. The individual Professors (including Associate Professors) and Lecturers of the Department shall have the right to make due, direct representations to the appropriate bodies and authorities of the College.
- 8. Office and laboratory accommodation shall be assigned to each Professor, each Associate Professor, and each Lecturer in the Department in accordance with the norms and procedures of the College. The remaining teaching, laboratory and other accommodation shall be departmental facilities, and their use shall be determined by the Head of Department subject to the approval of the President.
- 9. Proposals for expenditure on capital equipment and the recurring costs of the Department shall be presented on a departmental basis to the appropriate College authority by the Head of Department. Such funds as may be granted by the authority shall be allocated by the Head of Department.
- 10. Proposals for changes in the terms of this Chapter will be considered by the Governing Body, after their consideration by the Faculty of Science and the Academic Council,

PROVIDED that no change will be considered within the period of two years from the taking up of duty by the first Head of Department; and

PROVIDED that proposals for changes are signed by not

less than two-thirds of the serving members of the Departmental Committee.

Notwithstanding the foregoing provisos, no statutory right of any individual may be infringed.


- 11. The statutory provisions herein set forth shall be subsumed into the Conditions of Appointment and Particulars of Duties of the existing members, both statutory and non-statutory, of the academic staff of the Department of Experimental Physics who have assented in writing to such changes in the conditions of appointment attaching to their present posts as may be necessitated by the Statutory provisions herein set forth,
 - THAT IS TO SAY:-
 - Professor Declan Larkin, Professor of Electron Physics; Professor George F. Imbusch, Associate Professor of Physics;
 - Dr. Thomas O'Connor, Lecturer in Experimental Physics; Dr Aodhagán Ó Rodaighe, Lecturer in Experimental Physics,
 - Dr. James Larkin, Junior Lecturer in Experimental Physics.
- 12. 'The Statutory provisions herein set forth shall be further subsumed into the Conditions of Appointment and Particulars of Duties of the future members (if any), both Statutory and non-Statutory, of the academic staff of the Department of Experimental Physics.

CHAPTER III

- 1. Nothing herein contained shall affect any appointment made, right acquired, or act done under any previous Statute of the College
- 2. This Statute shall come into operation on the twenty-seventh day of November, One Thousand Nine Hundred and Seventyfour and may be eited as Statute XCIX of University College, Galway, or Stat. XCIX Univ. Coll., Galway
