

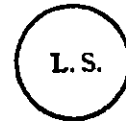

**STATUTE XCVIII**

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

**SCHEDULE—STATUTE XCVIII**

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

**CHAPTER I**

**PENSION SCHEME: NON-STATUTORY STAFF**

The provisions of Statute LI, Chapter 1, as amended by Statute LXXX, Chapter 1, and any additions or modifications thereto, shall apply to the participants in Pension Fund No. 2 as listed in the Table A referred to in Statute LXI.

**CHAPTER II**

**WIDOWS' PENSION SCHEME**

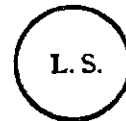
1. The 'current salary' referred to in this Statute shall mean the salary for the time being applicable at the same point on the salary scale as the participant had at the date of his death or retirement. In computing the current salary, for the purpose of this Statute no account shall be taken of any increase in salary due to a re-appraisal of the duties and responsibilities of the post. Should a pensionable post be abolished after the retirement or death of the holder, a relativity shall be established and maintained with a comparable post or group of posts equated to or related to that of the office held by the retired or deceased participant.

2. The proviso in Paragraph 1, Table A, Section 2 of Chapter I of Statute LXXIV whereby the maximum annual pension payable to a widow shall not exceed one-third of the salary payable to the participant at the date of his death is hereby revoked, and in lieu thereof is substituted the following proviso—subject to paragraph 1. PROVIDED always that the maximum annual pension payable to a widow shall not exceed one-third of the current salary attaching to the position held by the participant.
3. The proviso in Paragraph 2, Table A, Section 2 of Chapter I of Statute LXXIV whereby the maximum annual pension payable to the widow shall not exceed one-third of the final salary for pension purposes of the participant is hereby revoked and in lieu thereof is substituted the following proviso—subject to paragraph 1. PROVIDED always that the maximum annual pension payable to the widow shall not exceed one-third of the current salary attaching to the position held by the participant.

### CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-seventh day of November, One Thousand Nine Hundred and Seventy-four and may be cited as Statute XCVIII of University College, Galway, or Stat. XCVIII Univ. Coll., Galway.
