STATUTE XCVII

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE XCVII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS FROM 1ST JUNE, 1974 UNTIL 30TH NOVEMBER, 1974

1. Notwithstanding anything contained in any previous Statute of the College, the stipends and allowances attached to the Offices, Professorships and Lectureships referred to in Table A and in Table B to this Chapter shall, on and from the first day of June, 1974, be the stipends and allowances set forth in the said tables.
2. This Chapter shall be deemed to have come into operation on the 31st day of May, 1974.

TABLE A:

1. The annual stipend of the President shall be £9,588. In addition, he shall be entitled to residence, fuel and light as heretofore valued for pension purposes at £1,479 per annum, and to a non-pensionable allowance of £1,479 in respect of the expenses of his office.

2. The annual stipend of the holder of each of the following full-time offices namely:
 - (a) The office of Secretary-Bursar,
 - (b) The office of Academic Secretary,
 - (c) The office of Librarian,
 shall be £5,427 on appointment, increasing to a maximum of £6,555 by annual increments of £141.00 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
3. The annual stipend of the holder of each full-time Professorship shall be £5,427 on appointment, increasing to a maximum of £6,555 by annual increments of £141.00 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
4. The annual stipend of the holder of each full-time Associate Professorship shall be £5,796. The said annual stipend shall be non-incremental.
5. The annual stipend of the holder of each full-time Lectureship shall be £4,023 on appointment increasing to a maximum of £5,295 by annual increments of £159 for each completed year of service since appointment subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.

CHAPTER II

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS AS FROM 1ST DECEMBER, 1974

1. Notwithstanding anything contained in Chapter I of this Statute or in any previous Statute of the College, the stipends and allowances attached to the Offices, Professorships and Lectureships referred to in Table A and Table B to this Chapter shall, on and from the first day of December, 1974 be the stipends and allowances set forth in the said tables subject to the provision set forth in Chapter VI of this Schedule.
2. This Chapter shall be deemed to have come into operation on the 30th day of November, 1974.

TABLE A:

1. The annual stipend of the President shall be £10,113. In addition, he shall be entitled to residence, fuel and light as heretofore valued for pension purposes at £1,554 per annum, and to a non-pensionable allowance of £1,554 in respect of the expenses of his office.
2. The annual stipend of the holder of each of the following full-time offices namely:—
 - (a) The office of Secretary-Bursar,
 - (b) The office of Academic Secretary,
 - (c) The office of Librarian,
 shall be £5,738 on appointment, increasing to a maximum of £6,929 in accordance with Table B of this Chapter, subject to the provision where applicable of Chapter II of Statute LIV of University College, Galway.
3. The annual stipend of the holder of each full-time Professorship shall be £5,738 on appointment, increasing to a maximum of £6,929 in accordance with Table B of this Chapter, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
4. The annual stipend of the holder of each full-time Associate Professorship shall be £6,134.

5. The annual stipend of the holder of each full-time Lectureship shall be £4,282 on appointment increasing to a maximum of £5,608 in accordance with Table B of this Chapter, subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.

CHAPTER III

MARRIAGE AND CHILDREN'S ALLOWANCES FROM
1ST JUNE, 1974 UNTIL 30TH NOVEMBER, 1974

- Section 1 of Chapter III of Statute LXXXI of University College, Galway, is hereby amended: (a) by the substitution of the figure £126 for the figure £120 mentioned therein; (b) by the substitution of the figure £75 for the figure £72 mentioned therein; (c) by the substitution of the figure £37.50 for the figure £36 mentioned therein; (d) by the substitution of the figure £28.50 for figure £22.50 mentioned therein.
- This Chapter shall be deemed to have come into operation on the thirty-first of May, 1974, and the increased allowances set out in Section 1 thereof shall be payable as and from the first day of June, 1974 until 30th day of November, 1974.
- This Chapter shall be deemed to have lapsed with the coming into operation of Chapter IV of this Statute.

CHAPTER IV

MARRIAGE AND CHILDREN'S ALLOWANCES AS FROM
1ST DECEMBER, 1974

- Section 1 of Chapter III of Statute LXXXI of University College, Galway is hereby amended: (a) by the substitution of the figure £132 for the figure £126 mentioned therein; (b) by the substitution of the figure £81 for the figure £75 mentioned therein; (c) by the substitution of the figure £40.50 for the figure £37.50 mentioned therein; (d) by the substitution of the figure £30 for the figure £28.50 mentioned therein.

2. This Chapter shall be deemed to have come into operation on the thirtieth day of November, 1974, and the increased allowances set out in Section 1 hereof shall be payable as and from the first day of December, 1974, subject to the provision set forth in Chapter VI of this Statute.

PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement, or at date of death shall be £11,067 as and from the first day of June, 1974 and, subject to the provision of Chapter VI of this schedule, £11,667 as and from the first day of December, 1974, subject to the provision of Chapter VI of this Statute.

For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death, shall be £4,161 as and from the 1st day of June, 1974, and £4,402 as and from the first day of December, 1974.

2. Instead of the sums now being paid annually into the Statutory Pensionable Officers' Pension Fund, and into Pension Fund No. 2 there shall henceforth be paid and transferred to the said funds out of the annual Income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto such sums as an actuary shall certify to be necessary for providing Pensions and Gratuities.
3. On the coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships or Pensionable Offices shall be entitled to have their current pension calculated and paid in the manner and subject to the conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII, Statute LXXX and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV.

CHAPTER VI

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS FROM 1st MARCH, 1975

1. If during the period mid-November, 1973 to mid-November, 1974, the Consumer Price Index rises by more than 10 per cent, the stipends and allowances attaching to all the foregoing offices shall be increased by one per cent. for each one per cent. rise in the Index over that 10 per cent. The aforementioned increases, if such there be, shall be payable as and from 1st March, 1975.

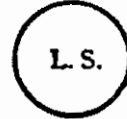
CHAPTER VII

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-seventh day of November, One Thousand Nine Hundred and Seventy-four and may be cited as Statute XCVII of University College, Galway, or Stat. XCVII Univ. Coll., Galway.
