**STATUTE CCCVIII**

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

**Schedule - STATUTE CCCVIII**

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## CHAPTER I

### ESTABLISHED PROFESSORSHIP

1. There is hereby established in the University the following fulltime Established Professorship:

**Established Professorship of Marine Biodiscovery.**

2. The annual stipend attaching to the foregoing Established Professorship shall be the same as that attaching from time to time to the fulltime Established Professorships of the University.
3. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

## CHAPTER II

### SENIOR LECTURESHIPS

1. There are hereby established in the University the following Senior Lectureships:

**Senior Lectureship in Physiology**

**Senior Lectureship in Medicine**

**Senior Lectureship in Anaesthesia and Critical Care Medicine**

**Senior Lectureship in Clinical Pharmacology**

**Senior Lectureship in Medicine of the Elderly.**

2. The annual stipend attaching to the foregoing fulltime Senior Lectureship in Physiology shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
3. (a) The holder of the foregoing Senior Lectureship in Medicine shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Physician to be established in conjunction with the

said Senior Lectureship by the Health Service Executive in University Hospital Galway/Merlin Park University Hospital Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant Physician, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.

- (b) The holder of the said Senior Lectureship shall devote twenty-six hours of his/her time to the duties of the said Senior Lectureship and eleven hours of his/her time to the duties of the foregoing office of Consultant Physician.
  - (c) The annual stipend attaching to the said Senior Lectureship shall be twenty-six thirty-sevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lectureship appointments.
4. (a) The holder of the foregoing Senior Lectureship in Anaesthesia and Critical Care Medicine shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Anaesthetist to be established in conjunction with the said Senior Lectureship by the Health Service Executive in University Hospital Galway/Merlin Park University Hospital Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant Anaesthetist, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
- (b) The holder of the said Senior Lectureship shall devote one-half of his/her time to the duties of the said Senior Lectureship and one-half of his/her time to the duties of the foregoing office of Consultant Anaesthetist.
  - (c) The annual stipend attaching to the said Senior Lectureship shall be one-half of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lectureship appointments.
5. (a) The holder of the foregoing Senior Lectureship in Clinical Pharmacology shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Physician in Clinical Pharmacology and Therapeutics to be established in conjunction with the said Senior Lectureship by the Health Service Executive in University Hospital Galway/Merlin Park University Hospital Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant Physician in Clinical Pharmacology and Therapeutics, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
- (b) The holder of the said Senior Lectureship shall devote one-half of his/her time to the duties of the said Senior Lectureship and one-half of his/her time to the duties of the foregoing office of Consultant Physician in Clinical Pharmacology and Therapeutics.
  - (c) The annual stipend attaching to the said Senior Lectureship shall be one-half of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lectureship appointments.

6. (a) The holder of the foregoing Senior Lectureship in Medicine of the Elderly shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Physician in Geriatric Medicine to be established in conjunction with the said Senior Lectureship by the Health Service Executive in University Hospital Galway/Merlin Park University Hospital Galway. In the event that the holder of the Senior Lectureship ceases to hold the said office of Consultant Physician in Geriatric Medicine, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
  - (b) The holder of the said Senior Lectureship shall devote one-half of his/her time to the duties of the said Senior Lectureship and one-half of his/her time to the duties of the foregoing office of Consultant Physician in Geriatric Medicine.
  - (c) The annual stipend attaching to the said Senior Lectureship shall be one-half of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lectureship appointments.
7. The holder of each of the said part-time Senior Lectureships shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
  8. Each of the foregoing Senior Lectureships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
  9. The holder of each of the said Senior Lectureships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
  10. The holder of each of the said Senior Lectureships shall carry out the duties of the Senior Lectureship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

#### CHAPTER IV

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the twelfth day of December, Two Thousand and Eight, and may be cited as Statute CCCVIII, National University of Ireland, Galway, or Stat. CCCVIII, Nat. Univ. of I., Galway.
