STATUTE CCLXXXVIII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCLXXXVIII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ACADEMIC COUNCIL

1. Statute CCLIV, Chapter I, as amended by Statute CCLXXIII, Chapter II and Statute CCLXXIX, Chapter III, is hereby further amended by the addition of the following Paragraph to Section 1 thereof:

“(xix) Such Adjunct Professors as may be appointed from time to time as members by the Standing Committee of the Academic Council in accordance with procedures approved from time to time by the Academic Council, provided that each such Adjunct Professor shall cease to be a member of the Academic Council when (s)he ceases to hold the title of Adjunct Professor.”

CHAPTER II

FACULTY MEMBERSHIP

1. Notwithstanding anything contained in any previous Statute of the University, and in particular in Chapter XI of Statute XVII, in Chapter I of Statute CXI, in Chapter I of Statute CCIII and in Chapter I of Statute CCLXIX, the members of a Faculty shall include such Adjunct Professors, Adjunct Lecturers, Directors of a Centre, Directors of a School, Directors or Academic Coordinators of an academic or direct academic support unit and Directors of an academic programme as may be appointed from time to time as members of the said Faculty by the Standing Committee of the Academic Council in accordance with procedures approved from time to time by the Academic Council, provided that each such Adjunct Professor, Adjunct Lecturer, Director of a Centre, Director of a School, Director or Academic Coordinator of an academic or direct academic support unit and Director of an academic programme, as the case may be, shall not be eligible for election as Dean of the said Faculty and shall cease to be a member of the said Faculty when (s)he ceases to hold the title of Adjunct Professor, Adjunct Lecturer, Director of a Centre, Director of a School, Director or Academic Coordinator of an academic or direct academic support unit or Director of an academic programme, as the case may be.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the fifteenth day of October, Two Thousand and Four, and may be cited as Statute CCLXXXVIII, National University of Ireland, Galway, or Stat. CCLXXXVIII, Nat. Univ. of I., Galway.
