STATUTE LXIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE LXIII

All previous Statutes of University College, Galway shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

THE BURSAR

1. The office of Bursar shall henceforth be a full-time office. The Bursar shall not be at the same time a Professor, Lecturer or Assistant in the College nor shall he hold any other office of profit or employment without the prior sanction of the Governing Body. The Holder of the Bursarship shall resign if he becomes a member of the Governing Body.

2. The Bursar shall be appointed by and shall be removable by the Governing Body. Notwithstanding anything to the contrary contained in Chapter XLIX of Statute XVII of University College, Galway, the Bursar need not be selected from the Professors and Lecturers of the College but shall possess such academic and/or professional qualifications as may be prescribed by the Governing Body.

3. The Bursar shall be entitled, subject to the due fulfilment of his duties, to hold office until he shall have attained the age of sixty-five years. After attaining the said age a Bursar may be continued in Office by the Governing Body from year to year for a period not exceeding five years PROVIDED that such further continuance in office is recommended to the Governing Body by the President and is sanctioned by the Governing Body annually.

4. The Bursar shall discharge the duties which are prescribed by Chapter XXI of Statute XVII of University College, Galway and shall do and perform all other acts and duties in relation to the College as by the Statutes and regulations or decisions of the Governing Body he may be required to do and perform.

5. The salary of the Bursar shall be £2,600 per annum on appointment increasing to a maximum of £3,200 by annual increments of £60 for each completed year of service since appointment. The Governing Body may in its discretion and if the President (having regard to the qualifications and experience if any of the person appointed) so recommends fix the commencing salary at any point in the incremental salary scale applicable to the office.

6. (a) The Office of Bursar shall be a pensionable office within the meaning of Chapter XXV of Statute XVII of University College, Galway and the amendments thereto and shall be annexed to the appropriate table of the Pension Scheme.

(b) Pension and Gratuity shall be calculated and paid in accordance with the provisions of Chapters II and III of Statute XXXVI of University College, Galway and of the Statutes of the College.

(c) There shall be paid into the Pension Fund such additional sum as an Actuary shall certify to be necessary for providing such pension and gratuity as aforesaid.

(d) The annual salary for the purpose of calculating pension and gratuity in accordance with the relevant provisions of existing Statutes of the College shall be deemed to be that payable at date of retirement or death.

7. The Bursar shall be entitled to the annual allowances in respect of a wife and children payable pursuant to Statute XXXVII and Statute LV of University College, Galway.

## CHAPTER II

1. Nothing herein contained shall affect any appointment made right acquired or act done under any previous Statute of the College.

2. This Statute shall come into operation on the Fourteenth day of December, 1965 and may be cited as Statute LXIII, University College, Galway or Stat. LXIII, Univ. Coll., Galway.
