STATUTE LXX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE LXX

All previous Statutes of University College, Galway shall be read and construed with the alterations, modifications and additions hereinafter set forth.

CHAPTER I

STIPEND AND ALLOWANCES ATTACHED TO THE OFFICE
OF PRESIDENT

1. Notwithstanding anything contained in any previous Statute of the College, the stipend and allowances attached to the Office of President shall, on and from the first day of January, 1967, be the stipend and allowances as follows:—

The annual stipend of the President shall be £5,520. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £900 p.a., and to a non-pensionable allowance of £900 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

2. Notwithstanding anything contained in any previous Statute of the College:
 - (a) for the purposes of calculating the pension payable on the retirement of the President, the annual stipend payable at date of retirement shall be deemed to be £6,420;
 - (b) for the purposes of calculating the amount of gratuity payable at date of death or retirement of the President, the annual stipend payable shall be deemed to be £6,420.

CHAPTER II

THE WIDOWS OF STATUTORY PENSIONABLE OFFICERS
PENSION FUND

1. In addition to the sum of £1,200 per annum now being paid by the Governing Body into the Widows of Statutory Pensionable Officers Pension Fund, there shall be paid into the Fund as and from the first day of July, 1967, an additional sum of £800 per annum.
2. Notwithstanding the provisions of Section 3 of Chapter I of Statute XL each married male Statutory Pensionable Officer of the College shall contribute to the said Pension Fund such sum as the Governing Body may determine by this or any other Statute of the College or by their resolution unless the Governing Body, on the recommendation of the President, exempts any such Officer from such contribution.
3. Chapter II of said Statute XL as amended by Section 1 (c) of Chapter IV of Statute LIV of University College, Galway, is hereby further amended by the substitution in Section 3 thereof of the figure "£800" for the figure "£250" (amended to "£425" by Section 1 (c) of Chapter IV of said Statute LIV) mentioned therein.
4. Notwithstanding any of the provisions of said Statutes XL and LIV and, in particular, notwithstanding the provisions of Section 5 of Chapter II of said Statute XL, the widow of a Statutory Pensionable Officer who has died before having contributed each year over a period of at least ten years the annual amount as set out in Section 3 of Chapter II of said Statute XL as amended by Section 3 of Chapter IV of said Statute LIV and by the next succeeding section of this Chapter shall be entitled to a Pension, provided such Officer or his personal representative shall have contributed to the said Fund any such annual amounts as may have been due from him. Such pension shall amount to one tenth of the pension to which such widow would have been entitled if the said Officer had not died within ten years of his joining the said Fund, multiplied by the actual number of years during which the said Officer has contributed to the said Fund.
5. In addition to the sum provided for by Section 3 of Chapter II of said Statute XL (as increased by Section 3 of Chapter IV of said Statute LIV), there shall be henceforth paid into the Widows of Statutory Pensionable Officers Pension Fund by the Office-holders or Pensioners as the case may be (except by a Statutory Pensionable Officer who had retired prior to the 19th October, 1953, being the date of coming into operation of said Statute XL) an additional contribution amounting to 25% of an existing contribution. Such additional contribution shall be due and payable together with and on the same date as the sums for which each of such persons is or shall be liable as a condition of participation in the said Fund.

CHAPTER III

1. Notwithstanding anything contained in any previous Statute of the College:
 - (a) for the purposes of calculating the pension payable on the retirement of the Lady Superintendent, the annual stipend payable at date of retirement shall be deemed to be £1,583;
 - (b) for the purposes of calculating the amount of gratuity payable at date of death or retirement of the Lady Superintendent, the annual stipend payable shall be deemed to be £1,583.

CHAPTER IV

1. This Statute shall come into operation on the Twenty-fourth day of January, One Thousand Nine Hundred and Sixty-Eight, and may be cited as Statute LXX of University College, Galway, or Stat. LXX, Univ. Coll. Galway.
