#### Schedule – REGULATION 2/2018/*Sceideal* – *RIALACHÁN 2/2018*

All previous Regulations of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth./*Déanfar Rialacháin uile Ollscoil na hÉireann, Gaillimh, roimhe seo a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

## CHAPTER I

### ROLE AND STRUCTURE OF COLLEGE BOARDS

1. Pursuant to the provisions of Chapters 1-4 Statute CCCLXII concerning the structure of Colleges and Schools and the broad role of Heads of School and Deans, and the further provisions of Regulation 1/2018 detailing the role of Executive Deans and appointment procedures related thereto, Regulation 2/2018 hereby sets forth the principles applying to the role and operating structures of College Boards as follows:
  - (a) Each College in recognition of custom and practice shall decide on College Board structures, their relationships to College delegated committees and the manner in which meetings are planned and held.
  - (b) Each College Board shall have the right to take into consideration all matters bearing upon the studies within its scope.
  - (c) Each College Board shall be responsible for the transaction of all academic business specially pertaining to it, subject to approval by the Academic Council.
  - (d) Each College Board shall have the duty to draft regulations as to Degrees, Diplomas, Certificates, Scholarships and Prizes falling within its province and to draft the scheme of programmes of instruction and the time-tables and scheme of examinations of the College, subject to approval by the Academic Council.
  - (e) Each College Board, subject to approval by the Academic Council, shall have responsibility for academic regulations and processes, the nomination of External Examiners, the approval of academic interview and assessment boards, and advising on strategic academic planning.
  - (f) Each College Board shall ensure that College initiatives and achievements are profiled appropriately.
  - (g) Each College Board shall be chaired by the College Executive Dean and shall be responsible to the Dean for the exercise of its functions.
  - (h) The membership of College Boards shall be comprised in accordance with Chapter 1 of Statute CCCXX. In addition, the President and Registrar and Deputy President shall be ex-officio members of College Boards.
  - (i) Separate to and independent of each College Board, a College Executive Group, with membership in line with the University's requirement for gender balance, and inclusive of Heads of School, Research Institute Directors affiliated to the College, and others as will from time to time be co-opted by the Dean, will report as a group directly to the Dean and advise on College financial, administrative, and organisational matters.

## CHAPTER II

### COLLEGES AND SCHOOLS

1. It is hereby noted that Chapters 1 and 2 of regulation 3/2010 delineating University Colleges and Schools are superseded by Chapters 1 and 2 of Statute CCCLXII.

## CHAPTER III

1. This Regulation shall come into operation on the twenty sixth Day of October, Two Thousand and Eighteen, and may be cited as Regulation 2/2018, National University of Ireland, Galway, or Reg. 2/2018, Nat. Univ. of I., Galway.

## CAIBIDIL I

### RÓL AGUS STRUCHTÚR BHOIRD NA GCOLÁISTÍ

2. De bhun fhorálacha Chaibidlí 1-4 de Reacht CCCLXII a bhaineann le struchtúr na gColáistí agus na Scoileanna agus ról leathan na gCinn Scoile agus na nDéan, agus forálacha breise Rialachán 1/2018 a dhéanann cur síos ar ról na nDéan Feidhmiúcháin agus na nósanna imeachta ceapacháin a bhaineann leis sin, leagann Rialachán 2/2018 amach na prionsabail a bhaineann leis an ról agus le struchtúir oibriúcháin Bhoird na gColáistí mar a leanas:

**(a)** Cinnfidh gach Coláiste, mar aitheantas ar ghnás agus ar chleachtas, struchtúir Bhoird na gColáistí, a gcaidreamh le coistí tarmlichte ag an gColáiste agus an bealach ina ndéantar cruinnithe a bheartú agus a thionóil.

**(b)** Beidh de cheart ag gach Bord Coláiste gach gné a bhaineann leis an léann laistigh dá réimse a chur san áireamh.

**(c)** Beidh gach Bord Coláiste freagrach as gach gnó acadúil a bhaineann leis go speisialta, faoi réir fhaomhadh na Comhairle Acadúla.

**(d)** Beidh dualgas ar gach Bord Coláiste rialacháin a dhréachtú maidir le Céimeanna, Diplómaí, Teastais, Scoláireachtaí agus Duaiseanna laistigh dá réimse agus an scéim clár teagaisc agus amchláir agus scéim scrúduithe an Choláiste a dhréachtú, faoi réir fhaomhadh na Comhairle Acadúla.

**(e)** Beidh freagracht ar gach Bord Coláiste, faoi réir fhaomhadh na Comhairle Acadúla, as rialacháin agus próisis acadúla, as Scrúdaitheoirí Seachtracha a ainmniú, as boird agallamh agus measúnaithe acadúla a fhaomhadh, agus as comhairle a chur ar fáil maidir le pleanáil straitéiseach acadúil.

**(f)** Cinniteoidh gach Bord Coláiste go ndéantar próifiliú cuí ar thionscnaimh agus ar éachtaí an Choláiste.

**(g)** Is é Déan Feidhmiúcháin an Choláiste a bheidh mar chathaoirleach ar gach Bord Coláiste agus beidh an té sin freagrach don Déan maidir le feidhmiú a fheidhmeanna.

**(h)** Beidh ballraíocht Bhoird na gColáistí comhdhéanta de réir Chaibidil 1 de Reacht CCCXX. Ina theannta sin, beidh an tUachtarán agus an Meabhránaí agus Uachtarán Ionaid ina mbaill ex-officio de Bhoird na gColáistí.

**(i)** Ar leithligh ó agus neamhspleách ar gach Bord Coláiste, tuairisceoidh Grúpa Feidhmiúcháin Coláiste, ar a mbeidh ballraíocht ar aon dul le riachtanas na hOllscoile do chothromaíocht inscne, agus ar a n-áireofar Cinn Scoile, Stiúrthóirí Institiúidí Taighde atá cleamhnaithe leis an gColáiste, agus daoine eile a dhéanfaidh an Déan a chomhthoghadh ó am go chéile, mar ghrúpa go díreach chuig an Déan agus cuirfidh sé comhairle ar fáil maidir le cúrsaí airgeadais, riaracháin, agus eagraíochtúla an Choláiste.
