STATUTE XLIII.

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, Do by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE XLIII.

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I.

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS.

1. Notwithstanding anything contained in any previous Statute of University College, Galway, the stipends and allowances attached to the Statutory Offices, Professorships and Lectureships mentioned or referred to in Table "A"

to this Chapter and the stipends attached to the Professorships and Lectureships mentioned or referred to in Table " B " to this Chapter on and from the first day of April, 1956, shall be the stipends and allowances set forth in the said Table " A " and the stipends set forth in the said Table " B ".

2. This Chapter shall be deemed to have come into operation on the 31st day of March, 1956.

*Table " A ".*

1. The stipend of the President shall be £2,300 per annum, and, in addition, he shall be entitled to residence, fuel and light as heretofore, and to an allowance of £200 per annum in respect of the expenses of his office.

2. The stipend of the Registrar and Secretary shall be £540 per annum.

3. The stipend of the Bursar shall be £180 per annum.

4. The annual stipend of the holder of each of the following full-time Professorships, namely:—

- (a) Professorship of Modern Irish ;
- (b) Professorship of Old and Middle Irish and Celtic Philology ;
- (c) Professorship of Ancient Classics ;
- (d) Professorship of Mathematics ;
- (e) Professorship of Experimental Physics ;
- (f) Professorship of English Language and English Literature ;
- (g) Professorship of Chemistry ;
- (h) Professorship of Natural History ;
- (i) Professorship of Civil Engineering ;
- (j) Professorship of Anatomy ;
- (k) Professorship of Physiology ;
- (l) Professorship of Mathematical Physics ;
- (m) Professorship of Geology including Physical Geography and Mineralogy ;
- (n) Professorship of Romance Languages ;
- (o) Professorship of German ;
- (p) Professorship of History ;
- (q) Professorship of Philosophy ;
- (r) Professorship of Economics, Commerce and Accountancy ;
- (s) Professorship of Education ;
- (t) Professorship of Celtic Archaeology ;

shall be:—£1,450 on appointment increasing to a maximum of £1,800 by annual increments of £70 for each completed year of service since appointment, subject to the provisions, where applicable, as to reckoning years of service set forth in Section

4 of Table " A " to Chapter I of Statute XXXVII of University College, Galway, and as to added years set forth in Chapter III of Statute XLII of University College, Galway ; Provided that the annual stipend of the present holder of any of the foregoing full-time Professorships whose present annual stipend is less than £1,450 shall be £1,450 increasing to a maximum of £1,800 by annual increments of £70 for each completed year of service as Professor.

5. The annual stipend of the holder of each of the following full-time Lectureships, namely :—

- (a) Lectureship in Mathematics ;
- (b) Lectureship in Education (through Irish) ;
- (c) Lectureship in History (through Irish) ;
- (d) Lectureship in Ancient Classics (through Irish) ;
- (e) Lectureship in Economics, Commerce and Accountancy (through Irish) ;
- (f) Lectureship in Civil Engineering ;
- (g) Lectureship in Botany ;
- (h) Lectureship in Experimental Physics ;
- (i) Lectureship in Mathematical Physics ;
- (j) Lectureship in Chemistry ;
- (k) Lectureship in Romance Languages ;
- (l) Lectureship in Celtic Languages ;
- (m) Lectureship in Philosophy ;

shall be £900 on appointment increasing to a maximum of £1,320 by annual increments of £60 for each completed year of service since appointment subject to the provisions, where applicable, as to reckoning years of service set forth in Section 5 of Table " A " to Chapter I of Statute XXXVII of University College, Galway, and as to added years set forth in Chapter III of Statute XLII of University College, Galway ; Provided that the annual stipend of the present holder of any of the foregoing full-time Lectureships whose present annual stipend is less than £900 shall be £900 increasing to a maximum of £1,320 by annual increments of £60 for each completed year of service as Lecturer.

6. The stipends of the holders of the foregoing Statutory Offices, Professorships and Lectureships, where such are to be increased by annual increments, shall be calculated in accordance with Sections 4 and 5 thereof and the increased stipends so calculated or otherwise hereby fixed shall be payable on or after the first day of April, 1956.

*Table " B ".*

1. Subject to the provisos hereinafter attached to certain Professorships, the annual stipends of the Professorships and Lectureship set out in this Table shall be the respective sums

set opposite the respective titles of the said Professorships and the said Lectureship as follows :--

Professorship of Therapeutics, Pharmacology and Materia Medica ....	£ 675
Professorship of Surgery .....	900
Professorship of Medicine .....	900
Professorship of Midwifery and Gynæcology ..	900
Professorship of Law .....	600
Professorship of Ophthalmology and Oto-Rhino- laryngology .....	420
Professorship of Pathology .....	900
Professorship of Bacteriology .....	900
Lectureship in Mental Diseases .....	250

Provided that in respect of the Professorship of Therapeutics, Pharmacology and Materia Medica, Statute XXIX of University College, Galway, in its application to the holder of the said Professorship in the contingency provided for by the said Statute shall be read as if the figures and words "£360 per annum" were substituted for the figures and words "£188 per annum with £12 additional per annum so long as the additional income of the College shall continue" wherever these latter figures and words appear in the said Statute.

Provided also that in respect of the Professorship of Surgery, the Professorship of Medicine, and the Professorship of Midwifery and Gynæcology, Statute XXIX of University College, Galway, in its application to the holder of any of the said Professorships in the contingency provided for by the said Statute shall be read as if the figures and words "£540 per annum" were substituted for the figures and words "£188 per annum with £12 additional per annum so long as the additional income of the College shall continue" wherever these latter figures and words appear in the said Statute.

Provided also that Statute XLI of University College, Galway, in its application to the holder of the Professorship of Pathology or the holder of the Professorship of Bacteriology in the contingency provided for by Section 2 of Chapter I or Section 2 of Chapter II of the said Statute shall be read as if the figures and words "£540 per annum" were substituted for the figures and words "£450 per annum" where these latter figures and words appear in the said Sections.

## CHAPTER II.

### PENSION FUND.

1. In addition to the sum of £5,710 now being paid annually into the Pension Fund, there shall henceforth be paid and

transferred to the Pension Fund out of the annual income granted by the Oireachtas for the general purposes of the College or out of any other moneys of the College applicable thereto an additional annual sum of £1,250.

### CHAPTER III.

#### PENSIONS.

1. Notwithstanding anything contained in any previous Statute of the College the pension of each full-time Statutory Officer, each full-time Professor and each full-time Lecturer of the College and of each of the part-time Professors of Pathology and Bacteriology, save as is hereinafter provided, shall be calculated in accordance with the relevant provisions of existing Statutes of the College on the annual stipend payable at the date of retirement to such full-time Statutory Officer, full-time Professor and full-time Lecturer of the College or to such part-time Professor as aforesaid pursuant to the provisions of Chapter I of this Statute.

Provided that for the purposes of calculating the amount of pension payable on the retirement of (a) the President, (b) the present holder of the Professorship of Geology including Physical Geography and Mineralogy, (c) the present holder of the Professorship of Education, and (d) the Lady Superintendent, the annual stipend payable at the date of retirement shall be deemed to be

- (a) in the case of the President, £2,600; (b) in the case of the present holder of the Professorship of Geology, including Physical Geography and Mineralogy, £2,340; (c) in the case of the present holder of the Professorship of Education, £1,980; (d) in the case of the Lady Superintendent, £600.

2. Section I of Chapter III of Statute XXXVII of University College, Galway, is hereby revoked.

### CHAPTER IV.

#### GRATUITIES.

1. Notwithstanding anything contained in any previous Statute of the College the annual stipend of each full-time Statutory Officer, each full-time Professor and each full-time Lecturer of the College and of each of the part-time Professors of Pathology and Bacteriology for the purpose of calculating in accordance with the relevant provisions of existing Statutes of the College the amount of the gratuity payable on the death or retirement of such full-time Statutory Officer, full-time

Professor or full-time Lecturer or of such part-time Professor as aforesaid, save as is hereinafter provided, shall be the annual stipend payable at the date of death or retirement to such full-time Statutory Officer, full-time Professor or full-time Lecturer or to such part-time Professor as aforesaid pursuant to the provisions of Chapter I of this Statute.

Provided that for the purposes of calculating the amount of the gratuity payable on the death or retirement of (a) the President, (b) the present holder of the Professorship of Geology including Physical Geography and Mineralogy, (c) the present holder of the Professorship of Education, and (d) the Lady Superintendent, the annual stipend payable at the date of death or retirement shall be deemed to be

(a) in the case of the President, £2,600; (b) in the case of the present holder of the Professorship of Geology including Physical Geography and Mineralogy, £2,340; (c) in the case of the present holder of the Professorship of Education, £1,980; (d) in the case of the Lady Superintendent, £600.

2. Section I. of Chapter IV of Statute XXXVII of University College, Galway, is hereby revoked.

#### CHAPTER V.

#### PENSIONS AND GRATUITIES.

1. The Professorship of Surgery, the Professorship of Medicine, and the Professorship of Midwifery and Gynaecology shall be, but only as from the date of coming into operation of this Statute, pensionable Offices within the meaning of Chapter 25 of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pensions Scheme. The Holders of the said Professorships shall be entitled to Pensions and Gratuities under and in accordance with the Provisions of Chapters 2 and 3 of Statute XXXVI of University College, Galway. There shall be paid into the Pension Fund such additional sum as an Actuary shall certify to be necessary for the purpose of providing pensions and gratuities for the said Offices. For the purpose of calculating pensions and computing gratuities under and in accordance with the provisions of the said Chapters of the said Statute XXXVI the stipend of each of the said Professorships shall be £900 (but such stipend for such purposes shall be the sum only of £540 if in the circumstances of the appointment of any such Professor he becomes entitled to be paid a stipend only of £540 per annum).

## CHAPTER VI.

## NON-RECURRING PAYMENTS.

1. Notwithstanding the provisions of any previous Statute of the College there shall be paid by the College to every person who held any part-time Statutory Professorship or Lectureship in the College during the whole or part of the year ended the 30th day of June, 1954, an additional sum equal to £5 per cent. of his stipend for the said year as the holder of such Professorship or Lectureship, and to every person who held any part-time Statutory Professorship or Lectureship in the College during the whole or part of the year ended the 30th day of June, 1955, a further additional sum equal to £5 per cent. of his stipend for the said year as the holder of such Professorship or Lectureship.

2. Notwithstanding the provisions of any previous Statute of the College the temporary increase of stipend hereinafter mentioned is hereby authorised to be paid to every person who held any Statutory Office, Professorship or Lectureship in the College during the whole or part of the nine months period from the 1st day of July, 1955, to the 31st day of March, 1956, that is to say, in respect of the said period of nine months an additional sum equal to £5 per cent. of the stipend actually paid or payable to him as the holder of such Statutory Office, Professorship or Lectureship.

## CHAPTER VII.

## LECTURESHIP IN CIVIL ENGINEERING (THROUGH IRISH).

1. There shall be established in the College in the event of its institution by the Senate of the National University of Ireland a Full-time LECTURESHIP IN CIVIL ENGINEERING, through Irish.

2. The stipend of the holder of the Lectureship in Civil Engineering shall be £900 on appointment increasing to a maximum of £1,320 by annual increments of £60 for each completed year of service thereafter. The holder of the Lectureship shall carry out his duties subject to the direction of the Professor of Civil Engineering.

3. The holder of the Lectureship shall deliver lectures and instruction through the medium of Irish alone.

4. The duties of the holder of the Lectureship, as regards amount and allocation of work, may be hereafter more fully defined by Regulations of the Governing Body.

5. The Lectureship shall be a Pensionable Office within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pensions Scheme. The Holder of the said Lectureship shall be entitled to Pension and Gratuity under and in accordance with the Provisions of Chapters 2 and 3 of Statute XXXVI of University College, Galway. There shall be paid into the Pension Fund such additional sum as an Actuary shall certify to be necessary for the purpose of providing pension and gratuity for the said Office. For the purpose of calculating pension and computing gratuity in accordance with the relevant provisions of existing Statutes of the College the annual stipend of the said Lectureship shall be deemed to be the annual stipend payable at the date of death or retirement of the Holder of the Lectureship pursuant to the provisions of Chapter VII of this Statute.

#### CHAPTER VIII.

1. For the purposes of this Statute

- (a) the full-time Statutory Officers of the College are the President and the Lady Superintendent;
- (b) the full-time Professors of the College are the holders of the Professorships set forth in Section 4 of Table "A" to Chapter I of this Statute;
- (c) the full-time Lecturers of the College are the holders of the Lectureships set forth in Section 5 of Table "A" to Chapter I of this Statute.

2. Nothing contained in this Statute shall affect any appointment made, right acquired, liability incurred or act done under any previous Statute of the College.

#### CHAPTER IX.

1. This Statute shall come into operation on the Eleventh day of December, One Thousand Nine Hundred and Fifty-six, and may be cited as Statute XLIII of University College, Galway, or Stat. XLIII Univ. Coll., Galway.
