STATUTE XXIX

WE the Governing Body of University College Galway under and by virtue of the powers in that behalf conferred on us by the above Act DO by this present instrument under the Seal of University College Galway make the Statute contained in the Schedule hereof for the general government of the said College.

SCHEDULE

1. All previous Statutes of University College Galway shall be read and construed with the alterations additions and amendments hereinafter set forth.

2. The Professor of Therapeutics Pharmacology and Materia Medica the Professor of Medicine the Professor of Surgery and the Professor of Midwifery and Gynaecology are required (as provided by Statute XVII Cap. XV Section 3) to give clinical instruction to the medical students of the College. In Order to make further necessary provision for such clinical instruction by reducing in certain circumstances the stipends attached to certain Professorships Chapter XVI of Statute XVII is hereby amended as provided in the four succeeding paragraphs hereof.

3. In Section 1 of Chapter XVI of Statute XVII after the words "The Professorship of Therapeutics Pharmacology and Materia Medica £308 per annum with £12 additional per annum so long as the additional income of the College shall continue," there shall be read and inserted the following: "If however the Professor of Therapeutics Pharmacology and Materia Medica shall not at the date of his appointment to the Professorship be Physician or Surgeon employed in a permanent and official capacity at the Galway Central Hospital then the stipend of the Professorship of Therapeutics Pharmacology and Materia Medica shall be £188 per annum with £12 additional per annum so long as the additional income of the College shall continue."

4. In Section I of Chapter XVI of Statute XVII after the words "The Professorship of Medicine \pounds_{336} per annum with \pounds_{14} additional per annum so long as the additional income of the College shall continue," there shall be read and inserted the following: "If however the Professor of Medicine shall not at the date of his appointment to the Professorship be Physician employed in a permanent and official capacity at the Galway Central Hospital then the stipend of the Professorship of Medicine shall be \pounds_{188} per annum with \pounds_{12} additional per annum so long as the additional income of the College shall continue"

5. In Section 1 of Chapter XVI of Statute XVII after the words "The Professorship of Surgery \pounds_{336} per annum with \pounds_{14} additional per annum so long as the additional income of the College shall continue" there shall be read and inserted the following: "If however the Professor of Surgery shall not at the date of his appointment to the Professorship be Surgeon employed in a permanent and official capacity at the Galway Central Hospital then the stipend of the Professorship of Surgery shall be \pounds_{128} per annum with \pounds_{12} additional per annum so long as the additional income of the College shall continue"

6. In Section I of Chapter XVI of Statute XVII after the words "The Professorship of Midwifery and Gynaecology the stipend of any subsequent holder shall be f_{308} per annum with f_{12} additional per annum so long as the additional income of the College shall continue," there shall be read and inserted the following "If however the Professor of Midwifery and Gynaecology shall not at the date of his appointment to the Professorship be the Obstetrician employed in a permanent and official capacity at the Galway.Central Hospital then the stipend of the Professorship of Midwifery and Gynaecology shall be f_{188} per annum with f_{12} additional per annum so long as the additional income of the College shall continue." 7. (a) If the holder of any of the four Professorships mentioned in the four preceding paragraphs hereof (the Professorship of Therapeutics Pharmacology and Materia Medica the Professorship of Medicine the Professorship of Surgery and the Professorship of Midwifery and Gynaecology) shall subsequent to his appointment to such Professorship become or be appointed Physician Surgeon or Obstetrician in a permanent and official capacity at the Galway Central Hospital then the stipend of the Holder shall be that provided by Section I of Chapter XVI of Statute XVII. Any such increase of stipend shall operate from the date of appointment to the Galway Central Hospital.

(b) If a Physician Surgeon or Obstetrician at the Galway Central Hospital be appointed Professor in the College his stipend shall be that provided by Section I of Chapter XVI of Statute XVII and he shall receive no remuneration from the College for Clinical teaching.

8. All moneys which shall become available to the Governing Body through the operation of the Amendments hereinbefore contained shall be devoted to the provision of clinical instruction for the medical students of the College and to the remuneration of extra-mural Examiners as the Academic Council may decide subject to review by the Governing Body.

9. The Professor of Ophthalmology and the Lecturer on Mental Diseases shall be required to give Clinical Instruction to the medical students of the College at such hours and in such hospitals as the Academic Council may prescribe subject to review by the Governing Body.

10. Nothing herein contained shall affect any appointment made right acquired liability incurred or act done under any previous Statute of the College.

11. This Statute shall come into operation on the Nineteenth day of May 1943 and may be cited as Statute XXIX of University College Galway or Stat. XXIX Univ. Coll. Galway.
