UNIVERSITY COLLEGE GALWAY.

STATUTE XXXII

WE the Governing Body of University College Galway, under and by virtue of the Powers in that behalt conferred on us by the above Acts DO by this present Instrument under the Seal of University College Galway, make the Statute contained in the Schedule hereof for the general government of the said College.

GIVEN under the Common Seal of University College, Galway, this Ninth day of December, 1946.

SCHEDULE-STATUTE XXXII

1. All previous Statutes of University College Galway, shall be read and construed with the additions, modifications and amendments hereinafter set forth. In particular section 2 of Statute XXIII, section 2 (10) I and section 3 (10) I of Statute XXIV, and section 5 (a) of Statute XXV shall be amended as hereinatter shall appear.

AMENDMENT OF STATUTE XXIII

- 2. (a) The Governing Body shall appoint a Board of Examiners of not more than five persons to test the competency of candidates for any office or situation in the College (save candidates for Demonstratorships and candidates for any office or situation to which the President has the right to appoint) to discharge the duties thereof through the medium of the Irish Language; provided however, that before appointing a Board, it shall obtain recommendations dealing therewith from the Academic Council.
 - (b) A new Board shall be appointed on the occasion of each and every vacancy in any office or situation in the College (save a Demonstratorship or office or situation to which the Presi-
 - dent has the right to appoint).

 (c) The members of a Board need not be Professors, Lecturers, or Assistants of the College but shall be members of the Academic Staff of a recognised University.

 (d) The members of a Board may act any number of times.

 (e) The President of the College shall be the Chairman of and an ex-officio member of every

 - Board. In the absence of the President the members of the Board present at each meeting shall appoint a Chairman for the meeting.

 (f) Three Members of a Board shall form a Quorum.
- 3. Every candidate for any Office or Situation in the College (save candidates for Demonstratorships and candidates for any Office to which the President has the right to appoint) shall submit himself for examination to and be examined by the Board in regard to his competency to discharge the duties of such office or situation through the medium of the Irish Language.
- The Several Provisions of Section 1 and of Sections 3 to 8 (inclusive) of Statute XXIII.
- University College Galway shall continue to apply and to govern the procedure of a Board appointed under this Statute in all respects as if it were the Board provided for in said Statute XXIII.

 5. (a) Every candidate for a Demonstratorship in the College shall submit himself for examination in regard to his competency to discharge the duties of his situation through the medium of the Irish Language to a Board of Examiners composed of such Members of the Academic Council (not exceeding five in all) as the Governing Body may appoint for that purpose.

 (b) Such Board shall be appointed triennally.

 - (c) A simple majority of the Members of any such Board shall decide any points of difference.
- (d) The President who shall be Chairman of any such Board shall have a casting vote.
 6. The Governing Body shall make such provision for payment of the remuneration and expenses of a Board appointed under Section 2 of this Statute as it may from time to time determine.

AMENDMENT OF STATUTE XXIV.

7. For the purpose of calculating gratuity of the President the salary of the Presidency includes and shall be deemed to have always included an allowance of £160 per annum for residence, fuel and light and Section 2 (10) I and Section 3 (10) I of Statute XXIV shall be read and construed accordingly.

AMENDMENT OF STATUTE XXV

- Section 5 (a) of Statute XXV. University College, Galway, shall be amended to read as follows:—
 "Section 17 Chapter XXV of said Statute XVII is hereby amended by the deletion in said.
 Section of all words from the words "and shall be proved" to the end of this Section, and the insertion in said Section in lieu thereof of the words "at its aboute discretion to state the state of the section of the words at its about description. to grant to such Officer or Servant such pension or such gratuity or both as it may deem reasonable, but out of funds other than the Pension Fund" and the said Section shall be construed and have effect accordingly.
- 9. This Statute shall not affect any appointment made, right acquired, liability incurred, or act done under any previous Statute of the College.
- 10. This Statute shall come into operation on the Ninth day of December, One thousand nine hundred and forty-six, and may be cited as "Statute XXXII University College Galway" or "Stat. XXXII Univ. Coll. Galway
