STATUTE XXXVIII.

We, the Governing Body of University College, Galway, under and by virtue of the Powers in that behalf conferred on us by the above Acts do by this present Instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereof for the general government of the College.

Given under the Common Seal of University College, Galway, this Eighth day of May, 1952.

SCHEDULE---STATUTE XXXVIII.

All previous Statutes of University College, Galway, shall be read and construed with the additions, modifications and amendments hereinafter set forth.

CHAPTER I.—INCREASED STIPENDS.

1. The annual stipends of the Professorships set out in the Table to this Section shall be the respective sums set opposite the respective titles of the said Professorships in the said Table.

Provided that Statute XXIX of University College, Galway, shall continue to apply to the Professorship of Therapeutics, Pharmacology and Materia Medica, the Professorship of Surgery, the Professorship of Medicine and the Professorship of Midwifery and Gynaecology but shall be read with the following variations :—

- (a) As if the Stipends therein set forth of the said respective Professorships were in each case £562/10 per annum.
- (b) As if the figures and words "£300 per annum" were substituted for the figures and words "£188 per annum with £12 additional per annum so long as the additional income of the College shall continue" wherever these latter words and figures appear in the said Statute.

2. The annual stipend of the Lectureship in Mental Diseases shall be £200.

3. The annual stipends of the Professorships set forth in the Table to Section 1 and the annual stipend of the Lectureship set forth in Section 2 of this Chapter shall be payable by the College as from the 1st day of April, 1950.

CHAPTER II.

1. Nothing in this Statute contained shall affect any appointment made, right acquired, liability incurred or act done under any previous Statute of the College.

2. This Statute shall come into operation on the Eighth day of May, One Thousand Nine Hundred and Fifty-two, and may be cited as Statute XXXVIII of University College, Galway, or Stat. XXXVIII Univ. Coll. Galway.
